Course Description

Designed to help adequate readers become superior readers. Recommended for college transfer students who wish to develop the critical reading and thinking skills necessary for all types of college level reading. Includes substantial practice in analysis and criticism of opposing stands on perennial social issues. (Formerly ENGL 111) (CSU)

4. Accurately analyze and criticize both inductive and deductive arguments.
5. Recognize and identify common fallacies in argumentation.
6. Demonstrate an ability to criticize argumentation by identifying hidden premises and assumed values in argumentation.
7. Show an understanding of techniques used to persuade.
8. Develop speed and a flexibility of reading skills appropriate to university demands.

9. Show growth in the ability to distinguish and identify word meanings.

Course Requirements and Instructional Methods

Except for Week 1, weekly reading assignment should be completed before class on Monday. You are responsible for observing all other assignment due dates and for coming to class prepared as many in-class activities are based on your preparation. Class time may be spent listening to brief lectures, taking notes, reading, thinking, writing, dialoguing, and collaborating on group tasks.

Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

Course Grading Based on Course Objectives

I will evaluate your preparation by giving six in-class exams, a final exam, and by assigning essays that give you the opportunity to display targeted critical thinking and analysis skills. I will also be collecting and grading selected classwork and assigning weekly online discussion questions and questions based on your reading. Aside from documented emergency situations, I will not grade late assignments or give make-up tests.

A final grade will be based on your weighted average in the following categories:

Attendance

- A student who fails to attend the first meeting of a class or to complete the first mandatory activity of an online class will be dropped by the instructor on the first official meeting of that class.
