# **Course Description**

This course is designed to review and reinforce proper use of the verbs "to be" and "to have", and the simple present and present progressive verb forms. It is a recommended supplement for students in Beginning and Low Intermediate ESL courses. (Nontransferable, nondegree applicable)

### **Student Learning Outcomes**

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

1. Select the correct verb to be versus to have needed to complete a passage in English (ISLO1).

### **Course Objectives**

Upon satisfactory completion of the course, students will be able to:

- 1. Demonstrate competency in understanding of the difference between the verb "to be" and the verb "to have" and to use them correctly in both oral and written forms;
- 2. Demonstrate competency in the understanding of the difference between the simple present and present progressive forms and be able to create sentences using the correct tense in both oral and written forms.

### **Textbooks & Other Resources or Links**

A dictionary is recommended. All other materials will be supplied by instructor.

### **Course Requirements and Instructional Methods**

Students will be required to complete a variety of assignments including worksheets, in class activities, short writing assignments, quizzes, and some oral assignments. Homework will be given after each class meeting and is to be turned in at the next class meeting.

<u>Out of Class Assignments</u>: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time <u>and</u> two (2)

hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

Students must have a final course grade of 70% or higher to pass the class.

#### **Attendance**
