Course Description

Concepts dealing with limits, continuity, differentiation and applications, integration and applications, Fundamental Theorem of Calculus, exponential and logarithmic functions, and other transcendental functions will be covered. (CSU) (UC credit limited. See a counselor.)

Course Prerequisite(s) and/or Corequisite(s)

MATH 190 with C or better or Math placement test

Student Learning Outcomes

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

1. Demonstrate problem solving strategies by identifying an appropriate method to solve a given problem, correctly set up the problem, perform the appropriate analysis and computation, and share their interpretation of the conclusion or the outcome, using correct grammar or in an oral presentation. This outcome will be assessed through selected exercises on exams throughout the semester. (ILO1, ILO2)

Course Objectives

Upon satisfactory completion of the course, students will be able to:

1. Demonstrate skills in understanding the concept of limit and be knowledgeable in finding limits, including tangent lines and computing the limit of a function at a real number.
2. Determine if a function is continuous and differentiable at a real number.

3. Demonstrate an understanding and a working knowledge of the derivative, including finding the derivative of a function as a limit, finding equations of tangent lines, computing derivatives using differentiation formulas, using implicit differentiation, and solving related rate problems.
4. Demonstrate proficiency in problem solving when dealing with applications of differentiation, including optimization.
5. Demonstrate knowledge in anti-differentiation.
6. Demonstrate an understanding and a working knowledge of the definite integral, including the evaluation of definite integrals as limits, using integration to find area, and the evaluation of integrals using the Fundamental Theorem of Calculus.
7. Graph functions using methods of Calculus.
8. Demonstrate a thorough understanding of logarithmic and exponential functions, and their use in applications dealing primarily with growth and decay phenomena.
9. Demonstrate the ability to deal with trigonometric, inverse trigonometric and hyperbolic functions and many common applications thereof.

Course Requirements and Instructional Methods

Material needed: textbook, paper, pen, pencil, highlighter, graphing calculator, (cell phone, or other such devices are allowed on the tests)

Course setting: This course is designed to have you learn facts while gaining an appreciation of the power of Mathematics and getting ready for your future courses in this field. My responsibility is to do my best to be an effective guide, while you are responsible to make a commitment to learning and keeping up with the daily work. Remember mathematics is learned through active participation.

On weekly basis you need to:

- Use notes and textbook to study the week's material and take notes from book
- Do the assignment.
- Participate in group study and tutoring sessions

Class Rules:

1. Late assignment is **not** accepted
2. **No** make-up test will be given
3. It is the student's responsibility to drop or officially withdraw from the class. (See IVC class schedule for dates).

Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

After each test, except the final exam, students will be able to retake a test covering the same sections as the test and improve their test score by maximum of 15 points on each test. The retest date and time will be announced at least 2 days before the retest which will be done on campus. Students have to make their schedule free for the retest time block and no other opportunities will be given for that purpose, as this is an optional activity and not a mandatory activity.

Attendance

- A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. Should readmission be desired, the student's status will be the same as that of any other student who desires to add a class. It is the student's responsibility to drop or officially withdraw from the class. See [General Catalog](#) for details.
- Regular attendance in all classes is expected of all students. A student whose continuous, unexcused absences exceed the number of hours the class is scheduled to meet per week may be dropped. For online courses, students who fail to complete required activities for two consecutive weeks may be considered to have excessive absences and may be dropped.

Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.
