Course Description: Continuation of MUS 156. This course will further students' development in choir performance. Maximum credit is 2 units. (CSU, UC) ***Course may be taken TWICE!!**, **Highly encouraged to do so!!***

Student Learning Outcomes: Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to 1. Increased knowledge and performance skills in a variety of choral repertoire from moderate to advanced levels of difficulty; and from genres including Classical, Jazz, Gospel, Easy-Listening, World Music, Spirituals, Songs from Musical Shows, Broadway Tunes, and Pop Tunes. Furthermore, students must show quasi-professional musicality and increasing ease of vocal production; 2. Additionally, students will continue to demonstrate professional decorum during public performances on and off-campus (ILO1, ILO2, ILO3, and ILO5)

Course Objectives: Upon satisfactory completion of the course, students will be able to: 1. correctly perform vocal parts from a varied literature for chorus, both accompanied and A Capella in concert; 2. Correctly perform assigned vocal parts from a varied literature for chorus, both accompanied and A Capella in rehearsal; 3. Demonstrate increasing mastery of interpretation of musical notation, dynamic markings, and musical expressivity terminology; 4. Demonstrate increasing awareness of harmonic intonation accuracy, vocal blend and vocal balance; 5. Recall details of composers studied in class, pertinent information about the eras of compositions sung, and appropriate performance practices; 6. Accurately memorize assigned vocal parts, plus show moderate memorization of vocal parts around them; 7. Sight-sing moderate-level choral repertoire with 80% accuracy using solfeggio (1, 2, 3, or do-re-me); 8. Show beginning to moderate ability to lead one's section in choral rehearsals and in concerts.

Class Requirements and Instructional Methods: Students are expected to attend choir class regularly and punctually. Students will participate wholeheartedly in all class activities, including warm-ups, rehearsal of varied choral repertoire, marking of musical scores as appropriate, and more. Students will attend scheduled musical performances and give of their best. Students will be orderly and disciplined during choir classes and performances, and

endeavor to maintain proper decorum. Talking should be minimized or non-existent during rehearsals and performances. Students will be great team-members of the choral ensemble. Students will gain confidence in themselves as blossoming musical artists. **Please note that this is a Choral Performance Class, hence participation in Concerts is important and mandatory. Concert/Performance Schedule thus Far:- Concert Performances on and off-campus in late-September, late-October, mid-November, and early-December 2017. Our Final Fall Concert will be on Sunday December 3rd, 2017 at 3:00pm, at First United Methodist Church, El Centro (312 S. Eighth Street).**

Class Attendance: A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class, will be dropped by the instructor as of the first official meeting of the class. Should readmission be desired, the student’s status will be the same as that of any other student who desires to add a class. It is the student’s responsibility to drop or officially withdraw from the class. See General catalog for details.

Regular attendance in all classes is expected of all students. A student whose continuous, unexcused absences exceed the number of hours the class is scheduled to meet per week, may be dropped.

Absences attributed to the representation of the college at officially approved events (conferences, contests, and field trips) will be counted as ‘excused’ absences.

Classroom Etiquette: Electronic Devices – Cell phones and electronic devices must be turned off and put away during class unless otherwise directed by the instructor. Food and Drink – are prohibited in all classrooms. Water bottles with lids/caps are the only exception. Disruptive Students – Students who disrupt or interfere with a class may be sent out of the room and told to meet with the Campus Disciplinary Officer, before returning to continue with coursework. Online Netiquette: What is netiquette? Netiquette is Internet manners, online etiquette, and digital etiquette all rolled into one word. Netiquette is a set of rules for behaving properly online. Students must comply with these rules of netiquette: (1) identify yourself, (2) include a subject line, (3) avoid sarcasm, (4) respect others’ opinions and privacy, (5) acknowledge and

return messages promptly, (6) copy with caution, (7) do not spam or junk mail, (8) be concise, (9) use appropriate language, (10) use appropriate emoticons (emotional icons) to help convey meaning, and (11) use appropriate intensifiers to help convey meaning (do not use ALL CAPS or multiple exclamation marks (!!!))

Academic Honesty: Plagiarism – is to take and present as one’s own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism, and keep it in mind when taking exams, and preparing written materials. If you do not understand how to properly cite a source, you must ask for help. Cheating – is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials, which are prohibited or inappropriate in the context of the academic assignment in question. Anyone caught cheating will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file. Repeated acts of cheating may result in an F in the course, and/or disciplinary action. Please refer to the General School catalog for more information on academic dishonesty or other misconduct.
