# **Course Description**

#### **Course Requirements and Instructional Methods**

#### **Assignments:**

<u>Out-of-class</u>: Plan a personal workout program that includes cardiovascular fitness, muscular strength, and body composition.

<u>Reading and Writing</u>: Read an article on the benefits of water. Write a paper describing your personal water consumption needs and include 3 benefits to proper water intake.

<u>Class activities:</u> include workout assignments, quizzes, tests, and homework.

#### **Course Grading Based on Course Objectives**

Final grade will be based on the total of points accumulated, 90%=A, 80%=B, 70%=C, 60%=D. Points come from Quizzes, Assignments, Fitness Assessments, Class Attendance, and Final Exam. Late assignments will receive only partial credit. No Extra Credit!

#### **Attendance**

- A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. Should readmission be desired, the student's status will be the same as that of any other student who desires to add a class. - Absences attributed to the representation of the college at officially approved events (conferences, contests, and field trips) will be counted as 'excused' absences.
- Workout clothing must be worn for all PE lab classes. If you do not dress out, you will not be permitted to attend lab classes. You must bring a towel to class.
- Lockers are available in the locker rooms. We do not assign them or provide locks. Larger lockers are for class time only.

# **Classroom Etiquette**

- Electronic Devices: Cell phones and electronic devices must be turned off and put away during class, unless otherwise directed by the instructor.

- Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.

Anyone caught cheating or plagiarizing will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file. Repeated
