### Course Description

This course is a continuation of MUS 162 with the following additions: 1.intermediate music reading in several keys; 2. Expanding knowledge of chords including sevenths, ninths, diminished, augmented. 3. Advanced picking techniques and finger style accompaniment. (CSU, UC)

### Student Learning Outcomes

- Perform beginning level-3 melodies (with accidentals) in first position with correct pitches, rhythm, fingering, at a reasonable tempo with expressions indications observed. (ILO1, ILO2, ILO4)
- Know and strum the 5 types of Barr Chords: Major, Minor, Dom7, Minor7, Major7. (ILO1, ILO2, ILO4)
- Know and perform one moveable major scale pattern in any key. (ILO1, ILO2, ILO4)
- Perform musical arrangements with other guitarists in an ensemble. (ILO1, ILO3, ILO4)

- reading musical notation in the treble clef while playing single-note melodies in first position, including accidentals.
- advanced picking techniques, finger style accompaniment
- bar and power chords
- various strum patterns for different time signatures and grooves
- scales and other technical exercises to reinforce muscle memory
- goal-setting and organizational skills by maintaining a practice journal

## Course Requirements and Instructional Methods

The class meeting time is 9:40-11:05 and will include lectures on music theory, instruction on guitar technique and literature, collaboration with peers on group songs, and self-directed practice labs.

Written Quizzes: Students will demonstrate knowledge of music theory and guitar fundamentals through periodic written quizzes.

Playing Quizzes: Students will demonstrate musical knowledge by individually performing songs or exercises for the instructor.

Self-Directed Practice Lab: Students will utilize in-class practice time to reinforce classroom lessons and advance to material at their own pace.

Performances: Students will perform at two open-mic events which will count as the midterm and final exams.

Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

### Attendance

### Classroom Etiquette

### Online Netiquette

- What is netiquette? Netiquette is internet manners, online etiquette, and digital etiquette all rolled into one word. Basically, netiquette is a set of rules for behaving properly online.
- Students are to comply with the following rules of netiquette: (1) identify yourself, (2) include a subject line, (3) avoid sarcasm, (4) respect others' opinions and privacy, (5) acknowledge and return messages promptly, (6) copy with caution, (7) do not spam or junk mail, (8) be concise, (9) use appropriate language, (10) use appropriate emoticons (emotional icons) to help convey meaning, and (11) use appropriate intensifiers to help convey meaning [do not use ALL CAPS or multiple exclamation marks (!!!)].

### Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- **Plagiarism** is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. If you do not understand how to "cite a source" correctly, you must ask for help.
- **Cheating** is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.
