An introduction to the concepts of Algebra. Topics covered include solving equations, polynomials, factoring, rational expressions, graphs and linear equations, systems of linear equations, and inequalities. (Nontransferable, nondegree applicable)

5. Demonstrate an understanding of skills in operations with and simplifications of rational expressions.

6. Demonstrate a visual understanding of the Cartesian Coordinate System and linear graphs.

7. Demonstrate the ability to solve linear systems of equations both algebraically and graphically.

8. Demonstrate the ability to solve linear inequalities algebraically and be able to present the solutions graphically.

Attendance

Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials.
