### Course Description

A course designed to provide students with a concentrated sequence of private instruction in music within a particular performing medium. One section meeting per week on campus, in addition to private instruction. as required conditions, the student must: 1. Secure a teacher approved by the College by the 2<sup>nd</sup> week of school. 2. Take 13 thirty-minute lessons or equivalent per semester 3. Meet on campus for performances as scheduled; and keep accurate records of lesson attendance, ensemble rehearsals, and personal/individual practice logs. (CSU,UC) 4. Present Applied Solo Repertoire in 2 Applied Music Students Concerts; and also participate in 1 Small Ensemble Concert. – Ensembles Concert (Thursday May 2<sup>nd</sup>, 2019 at IVC EXPO); 1<sup>st</sup> Solo Concert (Thursday May 9<sup>th</sup>, 2019); 2<sup>nd</sup> Solo Concert and Ensembles (Thursday May 30<sup>th</sup>, 2019). 5. Complete in a jury examination (Wednesday June 5<sup>th</sup>, 2019 or Thursday June 6<sup>th</sup>, 2019).

### Student Learning Outcomes

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

1. Acquire physical skills and dexterity on his or her declared, major instrument including voice. (ILO1, ILO2, ILO4)
2. Student will perform 6 major scales (or minor scales) from the lowest range to the highest range of their instrument/voice accurately and at a moderate tempo without a mistake. (SLO1, SLO2, SLO4)
3. Student will perform a classical composition (or song) correctly adhering to all rhythmic and pitch information. (ILO1, ILO2, ILO4)
4. First semester students will perform two songs or compositions that differ in style and character. (ILO1, ILO2, ILO4)
5. All Students will be required to sight-read appropriate level repertoire on Juried Exams

Two (2) hours of independent work done out of class per each hour of lecture or class work, or 3 hours lab practicum, or the equivalent per unit is expected.

Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

### Course Grading Based on Course Objectives

The student will prepare and perform before a jury of full-time music faculty and the private instructor representative literature and technical studies prepared during the semester. Judges will grade the performance based on the 11 aspects of music performance. Also, the 3 Semester Concert Performances (2 Solo Performances and 1 Small Ensemble Performance) will be Graded.

### Attendance

- A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of

an online class will be dropped by the instructor as of the first official meeting of that class. Should readmission be desired, the student's status will be the same as that of any other student who desires to add

a class. It is the student's responsibility to drop or officially withdraw from the class. See General Catalog for details.
