Course Description

The study of how personality and behavior are influenced by the social environment. The conceptual and research focus is on the relationship between the individual and society. This course includes such topics as: self-concept and social identity, group behavior and group membership. (Same as SOC 206)(CSU,UC)

5. Describe the group structure, dynamics, communication, leadership roles, that evolve from group membership.
6. Recognize differing techniques of persuasion and propaganda as well as social psychological Influences of attitude change.
7. Identify forces of conformity, cooperation, and social control, both internal and external.
8. List factors of interpersonal attraction and affiliation both formal and informal.
9. Describe social processes leading to personal and social respect, prestige, and status.
10. Explain social psychological influences on aggression, prejudice, and scapegoating.

Course Requirements and Instructional Methods

This course will consist of a combination of lectures, class discussion, assigned readings, videos, group and individual projects and performance on quizzes and exams.

Four exams will be given over the course of the summer session. Each exam will consist of multiple choice and fill in the blank items covering information presented in class and in the readings.

Oral individual and group classroom presentations based on chapter readings will also be required during scheduled dates. The average of exams and oral summaries and homework assignments will be calculated for your final grade

Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. - Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.
