Course Description

The study and performance of literature for symphony orchestra in a wide variety of styles. Performances in local communities and on campus are required. Maximum credit four units. (CSU,UC)

Course Prerequisite(s) and/or Corequisite(s)

Audition required.

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

4. *Exhibit knowledge of different stylistic performance practices; e.g., Baroque, Classical, Romantic, and/or Modern; as drawn from the literature studied. (ILO4, ILO5)*
5. *Exhibit knowledge of the musical repertoire of the symphony orchestra; e.g., Baroque, Classical, Romantic, and/or Modern; as drawn from the literature studied. (ILO4, ILO5)*
6. *Exhibit music reading and listening skills including resources for interpretation of notation and style, historical and cultural context through multiple sources. (ILO1, ILO2, ILO4, ILO5)*

Course Objectives

Upon satisfactory completion of the course, students will be able to:

1. *Perform assigned parts from selected literature for orchestra.*
2. *Demonstrate proper instrumental techniques.*
3. *Interpret music notation symbols of pitch, dynamics, and expression.*
4. *Recall details about the style, period, and performance practices of the composers and compositions studied in class.*
5. *Isolate technical performance problems in rehearsal, and systematically apply standard rehearsal techniques to them.*

Textbooks & Other Resources or Links

No textbook, as such, is required. Repertoire to be studied will be lent to the student from the Imperial Valley Symphony Association's library, or from public domain music downloaded from the Petrucci Library (International Music Score Library Project, imslp.org), or from music rented for use by the orchestra. This music is only lent for the period from the first rehearsal to the end of the concert for which it is planned. The music is expected to be returned in the same condition in which it was first lent to the student. It will be the student's responsibility to pay for lost or damaged music.

Course Requirements and Instructional Methods

Weekly rehearsals in Room 305, IVC, from 6:30-9:40pm will be held. IF, sectional rehearsals (announced at the rehearsal the week before) are needed, they will held from 6:30pm-7:30pm, with the full orchestra convening from 7:30pm-9:40pm (on those pre-announced dates)

Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

Also, TWO (2) Saturdays will be required for ALL students: March 23, 2019, and May 4, 2019, with 1-4pm, Dress Rehearsals and 7-10pm, CONCERTs (downbeat at 7:30) on those two Saturdays. The venue will be in the Jimmie Cannon Performing Arts Theatre, on the campus of Southwest High School, 2001 Ocotillo Dr., El Centro 92243.

In addition, a reduced orchestra (volunteers and selected musicians) will accompany the Imperial Valley Master Chorale in its spring concert: (one Monday rehearsal, with a Saturday or Sunday performance, dates TBA). This performance is NOT required, is strictly voluntary (but audition will be required to guarantee that the music can be played in just one rehearsal), and can count as extra credit for those who qualify (by the audition).

Course Grading Based on Course Objectives

1. 25% = Class Rehearsal Activities (5% Attendance, 5% Citizenship and rehearsal conduct, 15% Performance Quality (Music performed correctly))
2. 25% = Dress Rehearsal Activities: 5% Attendance, 5% Citizenship and rehearsal conduct, 15% Performance Quality (music prepared and performed correctly)

3. 50% = Live Concert Performance: 5% Punctuality, 5% Concert Attire, 5% Stage Presence, and 35% Performance Quality (music prepared and performed correctly)

Attendance
