## **Course Description**

Topics covered include linear and quadratic equations, relations, functions and graphs, systems of equations, logarithmic and exponential functions, conic sections, and sequences and series.

## Course Prerequisite(s) and/or Corequisite(s)

MATH 081 with a grade of "C" or better or appropriate placement.

## **Student Learning Outcomes**

- 1 Solve quadratic equations by factoring, completing the square, and quadratic formula. (ILO2)

- 4 Perform operations on functions algebraically. (ILO2)
- 5 Solve an application involving exponential functions. (ILO2, ILO5)

- 2. Demonstrate an understanding of quadratic functions, including graphing and equations.
- 3. Demonstrate an understanding of functions and relations, including one to one functions.
- 4. Demonstrate an understanding of logarithmic and exponential functions and their graphs.
- 5. Classify and graph ellipses, parabolas, and hyperbolas.
- 6. Demonstrate an understanding of sequences and series and their operations.

## Course Requirements and Instructional Methods

- 1. <u>Exams or Tests</u>: There will be <u>3</u> tests and there will be <u>no</u> makeup exams given. Zeros will be given for all missed tests. Please refer to calendar for dates.
- 2. <u>Final Exam</u>: The common final will be given during the last week of the semester. A score of 0 will be given if the final is missed. Please refer to calendar for dates.
- 3. <u>Homework</u>: The purpose of homework is to provide students with sufficient practice to master all topics and to do well on tests and the final exam. Homework is done using MyMathLab (all assignments are listed online as well as the deadline). It is student's responsibility to complete them on or before the deadline. Please keep in mind that after the deadline you will not be able to work on any assignment because the program will lock it automatically. If your <u>overall score</u> is 80% or higher you will get full credit, otherwise your grade will be your overall percentage translated to points. For example: if you score 80%=100 points, if you score 72%=72 points.
  - a. The program usually offers a 14-day free trial but- in order to see your final HW grade- you will need to buy the access code or use the one you had for Math 071/081. No credit will be given if I cannot see your grade because you did not pay for the program. It is extremely important that you use the same first and last name as in the IVC roster otherwise you may not get credit for HW. Also, refrain from using someone's else account to do the HW. No exceptions!

- 4. As part of the HW section, we will have review questions/problems at the beginning/end of the class that need to be turned in for a grade (it counts as <u>class participation</u>). If you are absent or late, you will miss the points and unfortunately, there are no makeups.
- 5. There will be no extra credit. Students must learn the material to pass this course.
- 6. It is up most important that students review the material to do well on exams. Students are encouraged to form study groups and to attend tutoring sessions to keep up with assignments and to study for tests.
- 7. Students will not be allowed to make up an exam or final exam unless they have a powerful reason to miss a test (e.g. hospitalization, jury duty, etc. and bring the corresponding paperwork as evidence; it can be e-mailed as well). It is students 'responsibility to notify the instructor via e-mail or by phone to make appropriate arrangements.
- 8. Notes/formulas: During exams, students cannot use any notes unless otherwise directed by the instructor. No exceptions!
- 9. Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

## **Course Grading Based on Course Objectives**

The student's grade will depend on the following areas (not on total points):

Semester Tests: 60% There will be <u>3</u> tests and there will be no makeup exams given. Zeros will be given for

all missed tests.

Final Exam: 25% The final will be given during the last day of the semester. A score of 0 will be given if

the final is missed.

Homework 15% Done on MyMathLab.

**TOTAL:** 100% There is no extra credit. Students must learn the material to pass this course.

All grades are calculated by using the standard scale of: A = 100-90% B = 89-80%

Grades are displayed in Canvas and you must earn at least a "C" to pass the class.

#### Attendance

- A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. Should readmission be desired, the student's status will be the same as that of any other student who desires to add a class. It is the student's responsibility to drop or officially withdraw from the class. See General Catalog for details.
- Regular attendance in all classes is expected of all students. A student whose continuous, unexcused absences exceed the number of hours the class is scheduled to meet per week may be dropped. ## **Academic Honesty**

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.
