4. Student will demonstrate the correct way to pluck a guitar using a pick or their right-hand fingers. (ILO2, ILO4)

3. Perform accompaniments, using basic strums, to folk songs.
4. Transpose in elementary fashion.
5. Play melodies in first position.

Class Requirements and Instructional Methods: Students are expected to be at each class session with their music books/music sheets, and guitar. Classes will begin with tuning of instruments, then, the instructor will lead students through various appropriate musical activities (reading chord charts, playing basic chords, performing accompaniments using basic strums to folk songs...and singing along!, transposing in elementary fashion, playing solo melodies in first position, doing group ensemble work, and learning to read basic musical notation appropriate for elementary guitar selections). Students will also practice by themselves, as well as in small groups, during the class sessions. In addition to in-class activities, students are expected to practice on their own, outside of class times. It is recommended that students practice guitar for at least 30 minutes, 3 days per week for level 1.

*Our class will do 2 public Concerts – Individual Solos; as well as Small and Large Ensemble Guitar Playing (and singing!) for Grading. **Your Mid-Semester Concert will be on Saturday April 11 th , 2020 at 9:00am, in Room #305. It will be open to the Public. Please invite Guests. Your Final Spring Concert will be on Saturday June 6th, 2020 at 9:00am, in Room #305. It will be open to the Public. Please invite Guests**.*
