1. Demonstrate a knowledge of four-part harmonization using modulations to distant keys though sight-singing, keyboard performance, and written analysis.
2. Demonstrate a knowledge of four-part harmonization using demised seventh chords thought sight-singing, keyboard performance, and written analysis.

3. Demonstrate a knowledge of four-part harmonization using borrowed and altered chords through sight-singing, keyboard performance, and written analysis.
4. Demonstrate a knowledge of four-part harmonization using ninth, eleventh, and thirteenth chords through sight-singing, keyboard performance, and written analysis.
5. Correctly notate two-part dictation.
6. Demonstrate a knowledge of twentieth-century compositional techniques, including serialism through sight-singing, keyboard performance, and written analysis.

*All Musicianship classes will have a number of Composition Projects assigned throughout the semester. All will be graded. There will be 3 written ear-training quizzes, as well as sight-singing tests. There will be NO make-up exams, except in documented extenuating circumstances. If a*

*quiz is made-up, it must be done no later than 1 week following the original date of the quiz.*

*No exceptions!*
