Crimes against persons, property, government, and organized crime are discussed. (CSU, UC)

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

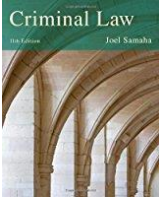
1. Identify the difference between criminal law and civil law. (ILO1, ILO2, ILO4)
