Course Description

EMT 105

I. COURSE/CATALOG DESCRIPTION: EMTP202 - Trauma Emergencies - Paramedic



This course is to prepare individuals to render prehospital advanced life support within an organized EMS system based on course content that is equivalent to the current U.S. Department of Transportation's National Education Standards for Paramedics. Trauma, including trauma systems, mechanism of injury, hemorrhage and shock, soft tissue trauma, burns, head/facial trauma, spinal trauma, thoracic trauma, abdominal trauma, and musculoskeletal trauma. This course teaches paramedic treatments and skills associated with the above core content. This program is accredited by the CAAHEP. (CSU). This course also features a 2 day PHTLS Corse put on by the NAEMT.

Student Learning Outcomes

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as Demonstrated by being able to:

- 1 Demonstrate the ability to complete a Prehospital Trauma Life Support Class by passing a Cognitive and Psycho motor examinations set forth by NAEMT (ILO 2, ILO 3)
- 2 Demonstrate the ability to assess and treat a trauma patient using a predetermined scenario and an NREMT skills check-off form. (ILO1)

3 Assess and treat trauma patients as measured by using observer evaluations during simulations. (ILO2, ILO3, ILO4)

Course Objectives

Upon satisfactory completion of the course, students will be able to:

- 1. Demonstrate knowledge of, and be able to integrate pathophysiological principles and assessment findings, to form Demonstrate knowledge of indications, equipment needed, technique used, precautions, and general principles for skills covered in the trauma & medical modules, and be competent performing the skills on a practical exam.
- 2. Demonstrate knowledge of indications, equipment needed, technique used, precautions, and general principles for skills covered in the special considerations module, and be competent performing the skills on a practical exam.
- 3. Demonstrate by performance in simulations the integration of knowledge, skill acquisition, patient management, scene management, treatment, communication and documentation for all adult patient modules.
- 4. Demonstrate by performance in student simulations the integration of knowledge, skill acquisition, patient management, scene management, treatment, communication and documentation for all modules.
- 5. Demonstrate knowledge of safe use of medications used by paramedics in the field as measured by medication quizzes (knowledge) and practice in skills labs and simulations late a field impression and implement the treatment plan for the trauma & medical patient.

Note: A passing score on all Drug quizzes, Division exams and Final exams is a minimum of 80%. Any drug quiz or Division exam that is not passing must be retaken by arrangement with the instructor. A minimum of 80% is required to pass any quiz or exam that has to be retaken. The original failing grade will be entered in student grade record and that grade will be the grade the students quiz average is based on (Not the retake score) Paramedic interns must maintain a daily quiz score of 80%, and will be subject to being dropped if the average drops below 80%. All retakes must be completed prior to the final exam for this course and the daily quiz average must be 80% or higher or the student will not be allowed to take the final exam. The student will receive an F grade in the course and be dropped from the paramedic program. The Final Exam must be passed with an 80% on the first attempt. PHTLS must be completed to take the written final.

Attendance

- A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. Should readmission be desired, the student's status will be the same as that of any other student who desires to add a class. It is the student's responsibility to drop or officially withdraw from the class. See General Catalog for details.
- Regular attendance in all classes is expected of all students. A student whose continuous, unexcused absences exceed the number of hours the class is scheduled to meet per week may be dropped.

- Absences attributed to the representation of the college at officially approved events (conferences, contests, and field trips) will be counted as 'excused' absences.
- You are allowed 1 absence or 8 hours of class time.
- Mandatory Days: PHTLS and the Final are a mandatory part of the course. These days are required to progress in the course and they cannot be repeated. <u>Students missing a mandatory day may be dropped</u> from the course or receive a failing grade.
