# **Course Description**

This course will review the history, theories, models and state-of-the-art approaches to the prevention field. It will provide experiential learning which will enable students to examine and explore their own values and behaviors as they relate to the use and abuse of alcohol and other drugs. Prevention programs and activities appropriate for the individual, community, campus, parent/family, and work site will be reviewed. <u>Group Presentation:</u> Students will be required to submit a 5 page research paper (not including a reference page) identifying one the following:

Compare effectiveness of various prevention strategies.

Review alcohol and drug use and abuse on campuses of higher learning.

Identify the role of media literacy in education and prevention.

Identify community based education and prevention resources.

Identify prevention programs that have worked for individuals.

Review public policy and prevention legislation, Prop. 37, drug court.

Explore strategies for education and prevention in specific populations.

Identify prevention strategies for relapse and aftercare.

Students are expected to read all assigned chapters as noted in syllabus. Although, we may or may not cover all of the material shown and the dates are approximations, students will however be required to know all the material assigned in reading and other material given in class.
