### Course Description

This course is an introduction to the theory of discrete mathematics and introduces elementary concepts in logic, set theory, graph theory, number theory and combinatorics. This forms a basis for upper division courses in mathematics and computer science, and is intended for the transfer student planning to major in these disciplines. The topics covered in this course include methods of proof, sets and relations, functions, number theory, induction, recursion, counting principles and probability trees, permutations, combinations, introduction to computer programming, and graph theory. (C-ID MATH 160)

3. Apply graph theory to real world situations. (ILO1, ILO2, ILO4)

Upon satisfactory completion of the course, students will be able to:

1. Write proofs using symbolic logic and Boolean Algebra.
2. Use recursion to analyze algorithms and programs.
3. Use sets to solve problems in combinatorics and probability theory.
4. Apply matrices to analyze graphs and trees.
5. Use finite state machines to model computer operations

### Homework

There will be three tests. The purpose of these tests is to check your understanding of the concepts covered in the course. Most of the questions on these tests will require showing a significant amount of work. A correct answer with insufficient work will receive partial credit or no credit.

### Final Exam

At the end of the semester, a COMPREHENSIVE/CUMULATIVE Final Exam will be given. If you miss the final, it will be recorded as a zero.

## Attendance

### Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials.
