Course Description

A first course in differential and integral calculus of a single variable: functions; limits and continuity; techniques and applications of differentiation and integration; Fundamental Theorem of Calculus. Primarily for Science, Technology, Engineering & Math Majors

Math 190 or equivalent, or appropriate placement

Course Objectives

Upon satisfactory completion of the course, students will be able to: 1. Compute the limit of a function at a real number 2. Determine if a function is continuous at a real number 3. Find the derivative of a function as a limit 4. Find the equation of a tangent line to a function 5. Compute

derivatives using differentiation formulas 6. Use differentiation to solve applications such as related rate problems and optimization problems 7. Use implicit differentiation 8. Graph functions using methods of calculus 9. Evaluate a definite integral as a limit 10. Evaluate integrals using the Fundamental Theorem of Calculus 11. Apply integration to find area

Course Requirements and Instructional Methods

Homework

Homework will be assigned at each class meeting. They should be on stapled arranged in the correct order. Please write your name and section number on the top right corner. Late homework will NOT be accepted. No make-up homework. At the end of the semester one lowest homework score will be dropped. It is your responsibility to check the homework assignment even if you are absent. The first 10 minutes of class will be devoted to answering your questions.

Homework will be due by the date of each test.

Quiz/Pop-quiz/Group Work

A quiz or group work may be given at any time during any class period. It may not be announced. The number of quizzes or group work in the semester will be instructor's discretion. The purpose is to provide a feedback on the learning outcome. The lowest scores will be dropped.

Tests

There will be four tests. The lowest score of the chapter tests will be dropped. If a test is missed, it will be the test score that is dropped. The purpose of these tests is to check your understanding of the concepts covered in the course. Most of the questions on these tests will require showing a significant amount of work. A correct answer with insufficient work will receive partial credit or no credit.

*Bring your own papers and pens/pencils on test days.

Final Exam

At the end of the semester, a COMPREHENSIVE/CUMULATIVE Final Exam will be given. If you miss the final, it will be recorded as a zero.

Attendance

Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.
