### Course Description

NURS 80 is a nursing course that introduces nursing and the study of nursing, including the roles of the registered nurse, as well as profession-related and patient care concepts. A distinction is drawn among the roles of the health aide, vocational nurse, and registered nurse. The student will become familiar with the expectations and realities of becoming a student nurse. Using a variety of topics, activities, examinations, and general information, this course is designed to assist students in developing strategies for success in the nursing program. The focus will be on developing critical thinking, problem-solving, and clinical judgment skills. Emphasis is placed on the knowledge and skills needed to provide safe, quality care. The theoretical foundation for basic assessment and nursing skills is presented, and the student can demonstrate these skills in a clinical laboratory setting. The philosophy, conceptual framework, objectives, guidelines, and policies of the nursing program, as well as the student's role in developing accountability and integrity and in meeting the standards of academic and clinical conduct, will be affirmed.

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

1. Identify strategies for personal and academic success in the Imperial Valley College Associate Degree Nursing program. (IL03).
2. Demonstrate respect and sensitivity for the professional role through appropriate behavior, being prompt for clinical experience, meetings, learning activities, class, and assignment deadlines.
3. Identify reasons for dismissal from the ADRN program.

## Course Objectives

Upon satisfactory completion of the course, students will be able to:

1. Identify factors that promote or inhibit success in the ADRN program.
2. State changes needed in one's personal life to meet the challenges and demands of the ADRN program.
3. Identify activities designed to meet the challenges and demands to be successful in the ADRN program, including time management and study skills.
4. Develop critical thinking, problem-solving, and clinical judgment skills at the basic level.
5. Achieve a 92% on Math Examinations, and complete tests within the given time frame.
6. Recognize that the APA format is used for all written work in the ADRN program. Familiarize yourself with the APA format.
7. Educate yourself on the available financial resources, such as scholarships and financial aid.
8. Develop a plan for financial management while in the ADRN program.
9. Discuss the risks of employment while in the ADRN program.
10. Apply and analyze the information in the ADRN Student Handbook.
11. Review and discuss the parameters of the ANA Code of Ethics and pertinent ethical and legal concepts.
12. Discuss the role of the student nurse and the scope of nursing practice related to the established code of ethics, nurse practice acts, and professional registrations/ certifications.
13. Discuss reasons for dismissal from the ADRN program: unprofessional conduct, cheating, HIPAA violations.
14. Demonstrate basic nursing skills using proper techniques and measures that ensure patient safety: 60-second assessments, infection control, hand washing, vital signs, patient safety, positioning patients in bed, transferring patients and utilizing proper body mechanics.
15. Explain the principles and underlying concepts for the identified basic nursing skills.

## Attendance

- A student who misses the first-class meeting or does not complete the initial required activity may be dropped by the instructor, effective at the first official class meeting. A student who cannot attend the first class meeting due to an unforeseen emergency must notify the instructor. It is the student's responsibility to drop or officially withdraw from the class. - Students who are late for class three times in any nursing course will be considered absent for one day. Class includes lectures, clinical, and skills labs.
- Regular attendance in all classes is expected of all students. A student who has a continuous, unexcused absence exceeds the number of hours the class is scheduled to meet per week and may be subject to dismissal. NUR 80 is a face-to-face class course. There are 9 class meetings in this winter session. Missing more than 1 day of class may be considered for dismissal from the course. Please inform me of any emergency circumstances.
- Absences due to representing the college at officially approved events (such as conferences, contests, or field trips) will be considered 'excused' absences. Students actively enrolled in the Imperial Valley College Associate Degree Nursing Program are required to attend all classes and complete all course assignments. A student who reaches the maximum allowable number of hours will meet with the teaching team to discuss the situation and may be considered for dismissal.

## Face-to-Face Classroom/Clinical/Lab Practice Etiquette

Students must always adhere to the IVC nursing student code of conduct and professional behavior outlined in the RN student handbook when interacting face-to-face, in lab practice, and clinical settings. Those out of compliance with these standards and guidelines are subject to placement on a behavioral contract.

- Electronic Devices: Cell phones and electronic devices must be turned off and put away during class unless otherwise directed by the instructor.
- Students may not use recording devices in the classroom or skills labs unless they have been documented by the IVC Disability Support Program and Services (DSPS).

## Disruptive Students

**Children in the classroom:** Due to college rules and state laws, only students enrolled in the class are allowed to attend; children are not permitted.

1. Identify yourself. Greet your contact properly. Always use formal titles (i.e, “Dear Mrs. Ramirez,” Hello, Mrs. Mora.
2. Include a subject line
3. Be polite. Avoid sarcasm. Always remember to say “please” and “thank you” as necessary
4. Respect others’ opinions and privacy
5. Acknowledge and return messages promptly,
6. Copy with caution
7. Do not spam or junk mail
8. Be concise, positive, and friendly
9. Use appropriate language
10. Use appropriate emotions (emotional icons) to help convey meaning
11. Use appropriate intensifiers to help convey meaning [do not use ALL CAPS or multiple exclamation marks!!!!].
12. Proofread your email before sending it.

## **Academic Honesty**

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another’s work and recognize the importance of acknowledging and safeguarding intellectual property. There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Instead, they are intended to serve as examples of unacceptable academic conduct.

- **Plagiarism** is taking and presenting as one’s “own” the writings or ideas of others without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. If you do not understand how to “cite a source” correctly, you must ask for help.
- **Cheating** is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment.
- Anyone caught cheating or plagiarizing will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in their file.

**\*\*Note: RN student handbook policies on academic dishonesty supersede IVC General Catalog and may be subject to dismissal from the program.** Acts of cheating include but are not limited to, the following: (a) plagiarism; (b) copying or attempting to copy from others during an examination or on an assignment; (c) communicating test information with another person during an examination; (d) allowing others to do an assignment or portion of an assignment; (e) using a commercial term paper service.
