Course Description and Introduction:

Critical Thinking is a course created to help students develop their skills in reasoning, analysis and the use of logical argument. We will focus on skills for identifying claims, premises and conclusions and touch on topics such as truth, reasons, validity, soundness, and fallacies. We will also examine ways in which logic can improve essay and paper writing. All of these skills can be applied to other fields of study such as business, science, law, social science, ethics and the arts.

Course Requirements:

Final Grades will be determined by three exams, regular homework assignments, a short paper, participation in class and quizzes, as below:

Writing assignments will be due at the beginning of class. They will be graded by letters ranging from an A to an F. In some cases we will go over homework in class, but if time is running short you will be responsible for correcting your own work.

There will be four exams throughout the semester, three smaller exams and a comprehensive final. Before each exam I will tell you what kinds of topics will be on the test so you can prepare accordingly.

In addition to the homework and exams, there will be 4 pop quizzes. There will also be a short paper (4-6 pages) assigned near the end of the semester. The specifics of the paper will be covered in class.

Finally, a significant component of your final grade will be based on your participation in class. To do well in the class, you should attend class meetings on a regular basis. Also, you can participate by raising interesting questions and comments in class.

Plagiarism:

We'll talk about plagiarism on the first day of class so that everyone will know what exactly it is. Plagiarism means attempting to give the reader the idea that words or ideas in an essay are your own when in fact they are someone else's. This is a serious academic offense that can get you thrown out of college. Don't take chances! If you have questions about what should be documented or cited, please ask me.

Attendance:

-You may be absent from two classes with no consequences. If you miss more than two classes, then you must bring valid cumentation (doctor's note, jury duty notice, receipt from mechanic etc.) to the next class meeting or you will be dropped from the course. While you are in class you will be expected to turn cell phones off and not use them in any capacity. If you are late to class you are free to come in and join the class but you will be marked absent.
