Course Description

The standard course in freshman English, this course seeks to improve the student's ability to understand serious and complex prose and to improve the student's ability to write an exposition that is thoughtful and clear, including the production of a well-documented research paper.

Required Textbooks and Materials

Sharing textbooks will not be allowed in this class; each student is responsible to have her or his book. Copies of chapters from the book are a violation of copyright law and will be confiscated if discovered.

- This is a Web-mediated course. The student will need access to her/his IVC email account, WebStar, and Blackboard. The student is expected to check her/his IVC email account daily. Specific instructions and assignments will be available only through the Blackboard system.

- The student will need access to the Internet and to Microsoft Word for research and publication purposes.
- In addition, the student is expected to have a good, quality English dictionary. Bilingual students are encouraged to use a bilingual dictionary as well.
- In-class writing assignments must be completed in black or blue ink on standard $8\frac{1}{2} \times 11$ notebook paper with clean edges.
- The student will need a bound composition book in which to maintain an academic journal.
- In addition, the student should purchase four (4) large, 8¹/₂ x 11 Green/Blue books for inclass writing assignments.

Student Learning Outcomes

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

- 1. Read, analyze, and interpret a variety of written texts, including one single-author text.
- 2. Identify evidence, tone, purpose, and audience, and fallacies in a variety of written works.
- 3. Demonstrate a thorough understanding of the writing process, from development and drafting to revising and editing.
- 4. Demonstrate a command of varying writing patterns, such as comparison and contrast, definition, and argumentation.
- 5. Demonstrate an understanding of connotative and figurative language while writing for an academic audience.
- 6. Adapt writing strategies to the requirements of the writing situation (e.g., to essay exam or other timed writing, research writing, reflective writing).
- 7. Examine and analyze one's own writing and that of other students with a view towards improving the effectiveness of the written work.
- 8. Develop text analysis and interpretation supported by citations, synthesized with the study and application of documentation styles and library skills (including electronic databases) to produce a research paper.
- 9. Demonstrate an understanding of the writing process by writing at least four essays using a variety of rhetorical modes, along with one research paper, composing a minimum of 6,000 words.
- 10. Participate in a number of activities and areas of study as deemed appropriate by the instructor.

Evaluation of Student Progress

Student learning will be evaluated in six categories:

Description of Class Components

In-Class Essays [80 pts possible]

The student will prepare four written essays, in class, as assigned: (1) Definition, (2) Process Analysis, (3) Comparison/Contrast, and (4) Argumentation.

All in-class essays will be graded according to the guidelines for the ENGL 009 Common Essay Examination (**Pass/Fail**).

- Does the essay contain a clear thesis statement?
- Do the body paragraphs contain examples and details that support the thesis?
- Are the body paragraphs organized in a logical sequence in support of the thesis?
- Does the student writer demonstrate a command of grammar and punctuation?

All in-class essays must be written in an 8.5 x 11 Greenbook/Bluebook composition booklet. These essays must be written in a legible style, with accurate spelling, grammar, and appropriate content/tone. Illegible handwriting will constitute an *automatic* Fail.

Essays written in pencil, essays that are not double-spaced, and/or essays written on both sides of the paper will receive an *automatic* Fail.

These in-class essay assignments will be <u>timed assignments</u>; the student is expected to utilize the full amount of available time for pre-writing, drafting, and revising.

Essay Revisions [80 pts possible]

The student will revise each of the four in-class essays. The instructor will provide instructions for the typed revisions when the in-class essays (first drafts) are returned to the class.

The essay revisions will provide opportunities to improve one's writing skills and to demonstrate competence with the following:

- MLA formatting, Times New Roman 12 pt. font (*Patterson prefers* 14 pt.),
- a full reference to the article (prompt) provided in the introductory paragraph,
- at least one quote from the article in the body of the essay with a correct parenthetical reference, and
- correct documentation of source material(s).

Essay revisions are graded with points. Each essay is worth 20 points; two points are deducted for each critical error.

Essay Revisions: Critical Errors
No clear, identifiable thesis statement
Disorganized/rambling paragraph
Sentence fragment, comma splice, or run-on (fused) sentence
Punctuation errors (end punctuation, apostrophe, semicolon, and quotation mark)
Three different words misspelled
Two errors in agreement or verb forms
Two ELL syntax errors
Misquote
Incorrect (or missing) parenthetical reference

Reading Comprehension [60 pts possible]

Reading and exercises will be assigned from the required textbook and course handbook. Assignments are due by the beginning of the next class session (quizzes are posted in Blackboard); *late submissions will not be accepted*.

Quoting, Summarizing, Paraphrasing (paragraphs) [80 pts possible]

Over the course of several weeks, the student will be assigned reading from the textbooks, *10 Steps in Writing the Research Paper* and *Self-Leadership: How to Become a More Successful, Efficient, and Effective Leader from the Inside Out.* The student will prepare and submit brief summary paragraphs for each chapter assigned from the textbook.

The purpose of the summary paragraph writing is to provide the student with an opportunity to write *error-free paragraphs*. Each summary paragraph is worth three points. One point will be deducted for each error in verb use, sentence structure, or punctuation.

Additionally, the instructor will assign specific sections of the textbook chapters for the student to paraphrase. Each paraphrase is worth three points. One point will be deducted for each error in verb use, sentence structure, or punctuation.

The Academic Writing Project (Research Paper) [80 pts possible]

The major focus of this course is the development and publication of a research paper on leadership. The final draft of the research paper will exceed eight (8) full pages of text and will integrate supporting materials from at least eight (8) sources.

The research paper will be completed in stages with points possible for each stage.

- A preliminary bibliography is worth 5 points.
- A comprehensive outline is worth 25 points.
- The final draft of the research paper is worth 50 points.

The final draft of the research paper must be submitted through SafeAssign in Blackboard. Instructions for accessing Blackboard are provided in this Course Guide. The instructor also will set aside time in class to assist students with electronic submission of their final draft.

Team Projects [80 pts possible]

The student will gain additional experience and application of leadership skills through participation and completion of four team projects. Each student will be assigned to a team of four. Each member of the team will lead one of the four projects and will participate in the completion of the other three projects.

- A. **Punctuation** -- the team will prepare and deliver a Powerpoint or Prezi presentation which reviews the MLA punctuation rules. Proper MLA documentation of sources must be included.
- B. **Microsoft Word Strategies** -- the team will prepare and deliver a Powerpoint or Prezi presentation which explains basic MLA page formatting, font, alignment, and page numbering.
- C. Attribution and Documentation -- the team will prepare and deliver a Powerpoint or Prezi presentation which explains correct MLA in-text attribution and reference documentation for a book, an electronic book, a periodical article, an article from an online database, an interview, and an unpublished manuscript.
- D. **Fallacies** -- team will collaborate on a short essay which includes at least two (2) fallacies. The team will prepare the document and add clarification information which identifies the fallacies exemplified.

Additional information pertaining to these six categories is provided in the *English 110 Course Guide*, available in the Reprographics Office.

Attendance Policy / Disrespectful Behavior

The student is expected to attend every scheduled class period, to arrive in the classroom before class begins, and to remain in class until the class period concludes.

Official withdrawal from the course is the student's responsibility.

The instructor reserves the right to drop a student after a period of consecutive absences make it clear that the student is no longer participating in the course.

It is the student's responsibility to schedule proctored make up of missed in-class essays; a missed final examination cannot be made up.

The student shall assume an obligation to conduct herself/himself in a manner compatible with the college's function as an educational institution. Misconduct is subject to disciplinary action.

When attending class, it is required that the student demonstrate respect for the instructor and fellow students. *Coming to class unprepared is considered disrespectful behavior*. Perceived disrespect (or disruptive behavior) or other misconduct will prompt the removal of the student(s) from the class for the remainder of the class period.

Spelling and Penmanship

A text demonstrates the writer's skill and competence in composition. In this composition course, correct spelling, appropriate grammar, and legible penmanship are expected. Therefore, submitted assignments which lack correct spelling, appropriate grammar, or legible penmanship are not acceptable.

Plagiarism and Cheating

Submitting a paper or essay to the instructor is a form of publication protected by the appropriate copyright laws of the United States. Therefore, the use of another's words, phrases, ideas, and/or organization, delivered as the student's own words, phrases, ideas, and/or organization is plagiarism. *Any student found to have plagiarized materials in any writing assignment will receive a failing grade for the assignment.*

Given the definition of plagiarism, the following rule-of-thumb will apply to papers submitted in this class. Any three words (or more) taken in sequence from a published source, without correct punctuation and documentation, is considered plagiarism. For the purposes of this class, there is no difference between accidental and intentional plagiarism. Therefore, the student is warned to pay close attention to instruction provided regarding the use of quotation marks and the correct application of parenthetical references in one's essays.

Students are encouraged to join study groups and/or to seek tutoring assistance in the development of their writing skills. However, each student is expected to write her or his own papers. <u>Cheating</u> is defined as fraud, deceit, or dishonesty in an academic assignment or using or attempting to use materials, or assisting others in using materials, or assisting others in using materials, which are prohibited or inappropriate in the context of the academic assignment in question. *Any student found to have cheated will receive a failing grade on the exam or assignment*.

Repeated acts of cheating may result in an F in the course and/or disciplinary action. Please refer to the General School Catalog for more information on academic dishonesty or other misconduct. Acts of cheating include, but are not limited to the following:

- o plagiarism
- o copying or attempting to copy from others during an examination or on an assignment;
- o communicating test information with another person during an examination;

• allowing others to do an assignment or portion of an assignment use of a commercial term paper service.

The instructor may report incidents of plagiarism or cheating to the Campus Disciplinary Officer.

Maintenance of Records

The instructor will attempt to return to the student all class materials. The student should keep these materials until after the final grade has been posted and accepted. These materials will be needed in the event the student elects to challenge the posted final grade.

Materials not returned to the student by the final class meeting will be held in the instructor's office through the first four weeks of the next term. Any papers not retrieved by the student will become the property of the instructor and may be used (in part or whole) as sample texts in future courses.

Emergency Procedures

In the event it becomes necessary to evacuate the classroom, students should quickly gather their personal belongings and walk to the classroom's assigned area (avoiding the parking lot areas). The instructor, or other campus personnel, will join the students and remain with them until further instructions are available.
