(4) Demonstrate knowledge of budget, payroll, invoicing, and banking calculations on the calculator.

### Course Requirements and Instructional Methods

This course will review basic math concepts and apply those concepts to common business math problems with an emphasis on critical thinking.

### Attendance

### Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- **Plagiarism** is taking and presenting as one's own the writings or ideas of others, without citing the source.
