### **Course Description**

Advanced theory in the use of "hot sticks," specialized equipment, repair and maintenance of poles and lines (energized and de-energized), safety practices, local and state requirements, and lineman mathematics.

<u>Teaching Methods</u>: During this class you will have opportunity to participate in a variety of presentation and teaching methods. Lectures, including material not covered in your readings, class and group discussions requiring your active participation, films or field trips will supplement your required readings.

<u>Out of Class Assignments</u>: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time <u>and</u> two (2) hours of out-of-class time per week over the span of a semester.
