Course Description

The course includes a further discussion of the concepts of algebra. Topics covered include linear and quadratic equations, relations, functions and graph .systems of equations, logarithmic and exponential functions, conic sections, and sequences and series.

Attendance

Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.
