Course Description

This course explores the anatomy, pathophysiology, and related pharmacology treatments for diseases and conditions of the respiratory, cardiovascular, renal, integumentary, reproductive, and immune systems. The classification and indication for generic and trade name medications for these systems will be explored. Accurate use of medical vocabulary and descriptive terms is expected. (CSU)

- 9. List the classifications and indication for each drug (generic and trade name) related to treatment of

cardiovascular diseases or conditions.

- 10. Discuss the common side effects of drugs used to treat diseases and/or conditions of the cardiovascular system.
 - 11. Identify medical terminology associated with the renal system.
 - 12. Describe the normal anatomy/physiology related to the renal system.
 - 13. Discuss the common diseases/conditions and pathology of the renal system.
- 14. List the classifications and indication for each drug (generic and trade name) related to treatment of renal diseases or conditions.
 - 15. Discuss the common side effects of drugs used to treat diseases and/or conditions of the renal system.
 - 16. Identify medical terminology associated with the integumentry system.
 - 17. Describe the normal anatomy/physiology related to the integumentry system.
 - 18. Discuss the common diseases/conditions and pathology of the integumentry system.
- 19. List the classifications and indication for each drug (generic and trade name) related to treatment of integumentry diseases or conditions.
- 20. Discuss the common side effects of drugs used to treat diseases and/or conditions of the integumentry system.
- 21. Identify medical terminology associated with the reproductive system.
- 22. Describe the normal anatomy/physiology related to the reproductive system.
- 23. List the common diseases/conditions and pathology of the reproductive disorders.
- 24. List the classifications and indications for drugs (generic and trade name) related to treatment of reproductive disorders.
- 25. Discuss the common side effects of drugs used to treat diseases and/or conditions of the reproductive system.
 - 26. Identify medical terminology associated with the immune system.
 - 27. Describe the normal anatomy/physiology related to the immune system.
 - 28. List the common diseases/conditions and pathology related to the immune system.
- 29. List the classification and indications for drugs (generic and trade name) related to treatment of the immune system.
- 30. Discuss the common side effects of drugs used to treat diseases an/or conditions of the immune system.

Course Requirements and Instructional Methods

You will be graded on the following areas in this class: Homework, Quizzes, Tests, Classroom Participation, and Extra Credit.

- You will have weekly assigned reading. You will complete assigned homework via Blackboard and/or Canvas. Each assignment in due before class starts. No late homework will be accepted.
- You will have weekly quizzes based on assigned reading. If you are absent you must bring doctors
 note in order to make-up quizzes, you will be allowed to make up quiz the day you come back not

- You will have two exams: Mid-Term and Final. No make-ups are allowed.
- There will be a research paper for this class with the following requirements: 5 pages, 1 title page, 1 reference page with no less than 3 resources, Font: Times New Roman, size: 12. Research paper will be on a disease covering the topics for this semester (more to follow).
- Complete assigned reading on anatomy, physiology, pathology, and pharmacology dealing with
 the integumentary system, respiratory, cardiovascular, renal, and reproductive system. Search for
 website that is informative and confirms what was in your assigned reading. In your own words,
 summarize the information in a single page typed report and add the link, URL, or screenshot of
 the homepage of the website you used to confirm the information.
- Compose a 1 page typed report, with 3 resources/references on 1 common disorder of the integumentary system, respiratory, cardiovascular, renal, and reproductive system with 2 common drugs used to treat the condition and the common side effects of the drugs used. Cite your resources/references and ensure the paper is in your own words.
