Course Description: A continuation of MUS 220 (CSU, UC).

Course Prerequisite: Students should successfully pass MUS 220, Intermediate Harmony 1, with a grade of "C" or better, before attempting this course.

Student Learning Outcomes: Upon course completion, the successful student will have acquired new skills, knowledge and or attitudes by being able to 1. Demonstrate knowledge of non-chord tones, including appoggiaturas, escape tones, neighbor group and anticipations, and pedal point (ILO1, ILO2, ILO3, ILO4); 2. Analyze non-chord tones (ILO1, ILO2, ILO3, ILO4); 3. Analyze varied types of modulations (ILO1, ILO2, ILO3, ILO4)

Course Objectives: Upon satisfactory completion of the course, students will be able to: 1. Demonstrate a knowledge of four-part harmonization using modulation to distant keys through sight-singing, keyboard performance and written analysis; 2. Demonstrate a knowledge of four-part harmonization using diminished seventh chords through sight-singing, keyboard performance and written analysis; 3. Demonstrate a knowledge of four-part harmonization using borrowed and altered chords through sight-singing, keyboard performance and written analysis; 4. Demonstrate a knowledge of four-part harmonization using ninth, eleventh, and thirteenth chords through sight-singing, keyboard performance, and written analysis; 5. Demonstrate a knowledge of 20th century compositional techniques, including serialism through sight-singing, keyboard performance and written analysis.

Textbooks: 1. *Tonal Harmony*, by Stefan Kostka and Dorothy Payne (any edition)

Class Requirements and Instructional Methods: The student should read the appropriate text for the day's assignment prior to coming to class, be able to discuss and/or ask questions about the day's assignment. Classes will start with an explanation of the text for the current assignment by the instructor, and appropriate examples modeled. This will be followed by "self-tests" in which the student answers the questions in the textbook (also done at home before the next class). The next class will begin with discussions of the "self-tests" and after queries are answered, the assignment of the next section will be given. Thus, students are expected to work diligently on their own, as well as supervised. Make up exams will only be given for documented extenuating circumstances. Furthermore, make-up exams must be taken no later than 1 week after the original test date. No exceptions!

Class Attendance: A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class, will be dropped by the instructor as of the first official meeting of the class. Online Netiquette: What is netiquette? Netiquette is Internet manners, online etiquette, and digital etiquette all rolled into one word. Netiquette is a set of rules for behaving properly online. Students must comply with these rules of netiquette: (1) identify yourself, (2) include a subject line, (3) avoid sarcasm, (4) respect others’ opinions and privacy, (5) acknowledge and return messages promptly, (6) copy with caution, (7) do not spam or junk mail, (8) be concise, (9) use appropriate language, (10) use appropriate emoticons (emotional icons) to help convey meaning, and (11) use appropriate intensifiers to help convey meaning (do not use ALL CAPS or multiple exclamation marks (!!!))

Academic Honesty: Plagiarism – is to take and present as one’s own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism, and keep it in mind when taking exams, and preparing written materials. If you do not understand how to properly cite a source, you must ask for help. Cheating – is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting

others in using materials, which are prohibited or inappropriate in the context of the academic assignment in question. Anyone caught cheating will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file. Repeated acts of cheating may result in an F in the course, and/or disciplinary action. Please refer to the General School catalog for more information on academic dishonesty or other misconduct. Anticipated Class Schedule/Calendar, Highly Subject to be Changed depending on Class Progress

Weeks 1 – 4: Chapters 18 & 19: Modulations using diatonic common chords, key relationships, common chord modulations, analysis of modulations, sequential modulations, common tone modulations, monophonic modulations, direct modulations.

Weeks 5 – 9: Chapters 20 & 21: Binary and Ternary forms, rounded binary forms, 12-bar Blues, other formal designs, mode mixture, borrowed chords in major, modulations with mode mixture

Weeks 10 – 13: Chapters 22 & 23: Neapolitan chord augmented 6th chords; Italian, French and German 6th chords; other uses of augmented 6th chords.

Weeks 13 – 16: Chapter 24: Augmented 6th chords 2; Review and Final Exam.
