### Course Description

This course is designed to help students with a disability or multiple disabilities, to understand their computer usage capabilities and to determine, through an instructor evaluation, the appropriate hardware and software. (Nontransferable, AA/AS degree only)

### Course Prerequisite(s) and/or Corequisite(s)

A student must be eligible for services and instruction from the Disabled Student Programs and Services through appropriate verification of a primary disability by certificated personnel and be able to benefit from the programs and services offered by the High Tech Center.

### Student Learning Outcomes

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

- Log into the High Tech Center to record their hours so that they can receive credit for this course. Instructor will demonstrate the process to the students and they will ask for assistance as needed. By the end of the semester, 100% of the students will be logging into the lab independently or be responsible for requesting assistance from the instructor or lab assistants. (IL01, IL03)

### Course Objectives

Upon satisfactory completion of the course, students will be able to:

- The student will be assessed and evaluated for appropriate access devices so the student may be able to perform the following tasks: A. The student will demonstrate the ability to strike all keys on the keyboard with 70% accuracy. B. The students will demonstrate the ability to appropriately orientate and seat themselves before the computer with 70% accuracy. C. The student will demonstrate the ability to understand and appropriately respond to 70% of the instructor's instructions. D. The student will participate in the development of an IEP and will demonstrate comprehension of goals and objectives by restating them to the instructor with 70% accuracy.
- After initial trial use of access devices the student will demonstrate the ability to complete 70% of a given assignment using the access devices and appropriate software.

- Items of a personal nature, e.g. mouthstick, head wand, or unique access device, must be provided by the student.

### Course Grading Based on Course Objectives

- Students are required to complete 18 hours of logged lab time by 4:00 pm, Friday, December 1, 2017.
