**Course Description**

An introduction to framing, setting, guying poles, installation of conductors and grounds, and the laying out and constructing of an underground line system. (Nontransferable, AA/AS degree only)

3. Understand and describe the overhead distribution system including delta and wye connections, cutouts, switches, reclosers, sectionalizers, capacitors, and voltage regulators. (ILO1, ILO2, ILO3)
4. Understand the various troubleshooting techniques on underground and overhead transformers, and cable fault location. (ILO2, ILO3)

1. Practice standard safety procedures appropriate to the power utility industry.
2. Recognize and deal appropriately with hazardous materials in the power utility industry.
3. Operate and maintain a bucket truck, digger derrick, backhoe, and trencher.
4. Demonstrate the method(s) of connecting pole top transformers (single-phase and three phase)
5. Analyze and explain the procedures for troubleshooting and replacement of faulty pole top transformer components; i.e., cutouts, switches, capacitors, and voltage regulators.
6. Explain the procedures in locating cable fault sites.

Teaching Methods: Discussion of assignments and instructional methods will be a combination of all methods of instruction, which can be classified as telling, lecturing, or discussing; showing or demonstrating.

A	Focused and clearly organized. Contains advanced critical thinking and analysis. Convincing evidence is provided to support conclusions. Clearly meets or exceeds assignment requirements.
B	Generally focused with some development of ideas, but may be simplistic or repetitive. Evidence is provided to support conclusions. Occasional grammatical errors. Meets

	assignment requirements, but does not exceed.
<b>C</b>	Unfocused, underdeveloped, or rambling, but has some coherence. Minimal evidence is provided to support conclusions. Several grammatical errors. Meets minimum assignment requirements.
<b>D</b>	Unfocused, underdeveloped, and/or rambling. Limited evidence is used to support conclusions. Serious grammatical errors that impede overall understanding. Does not address the assignment requirements
<b>F</b>	Unfocused, underdeveloped, and/or rambling. Incomplete or too brief. No evidence is used to support conclusions. Serious grammatical errors that block overall understanding. Does not meet assignment requirements. Minimal to no student effort.

Late Assignments will be accepted until the graded assignment is returned to the class, but assessed a penalty of 10 points per calendar day it is late.

### Attendance
