Course Description

This course will explore the role of learning in the adaptation of humans and other animals to their changing environment. Research methodology, Pavlovian and operant theories, applications and implications, and higher order cognitive processes will be examined. (CSU, UC)

4. describe theories, procedures, limits, applications, and implications of vicarious learning in humans and other animals
5. describe the partial reinforcement phenomenon with its theories, limits, and implications
6. define “thinking” including its relationship to learning, cognitive processes, and memory

Course Requirements and Instructional Methods

You are expected to read all assigned chapters even though not all may be discussed in class. Exam and quiz questions will come from material covered in class and in the textbook. There will be several quizzes, several thought papers, midterm exam, and one final exam. *BE PREPARED FOR THE POSSIBILITY OF UNANNOUNCED QUIZES.* Quizzes may include any or all of the following types of questions: multiple choice, true-false, matching, fill-in-the-blank, and short answer/essay.

The midterm and final exams are entirely multiple choice. If you are late to class, you may not be allowed to take the quizzes or exams. Some chapters listed may not be covered in class, but you are still responsible for the material, unless otherwise specified. No makeups for exams or quizzes will be given without prior notification and/or documentation of an emergency. No work will be accepted over email. If you find that you are having difficulty with the course, you can seek additional assistance (see below). In addition, if you need special accommodations while taking exams or quizzes let me know in advance. A final project will be assigned discussing the elements of a learned condition and what process what utilized to achieve the new behavior. Further detail will be discussed in class.

Attendance

- Students are to comply with the following rules of netiquette: (1) identify yourself, (2) include a subject line, (3) avoid sarcasm, (4) respect others' opinions and privacy, (5) acknowledge and return messages promptly, (6) copy with caution, (7) do not spam or junk mail, (8) be concise, (9) use appropriate language, (10) use appropriate emoticons (emotional icons) to help convey meaning, and (11) use appropriate intensifiers to help convey meaning [do not use ALL CAPS or multiple exclamation marks (!!!!)].

Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. If you do not understand how to "cite a source" correctly, you must ask for help.
- Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.

Anyone caught cheating or plagiarizing will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file.
