Course Description

An introduction to the mathematical concepts needed for further study in Algebra. Topics covered will include the real number system, variable expressions, solving equations, measurement and conversions, and geometry.

Course Prerequisite(s) and/or Corequisite(s)

MATH 061 with a grade of C or better, or appropriate placement.

Student Learning Outcomes

By the end of this course, given a problem or a set of problems, the student will demonstrate problem solving strategies by identifying an appropriate method to solve a problem, correctly set up the problem, perform the appropriate analysis and computation, and share their interpretation of the conclusion or the outcome, using correct grammar or in an oral presentation.

Course Objectives

Through various activities and assessments, students will:

1. Demonstrate skills in working with real numbers.
2. Demonstrate an understanding of variable expressions.
3. Demonstrate an understanding of solving equations.
4. Demonstrate an understanding of the English and Metric measurement systems in a wide variety of settings.
5. Apply relevant formulas in application problems involving a variety of geometric figures.

Textbooks & Other Resources or Links

Textbook: Developmental Mathematics, 1E by Blitzer, Pearson Publisher. You can purchase this textbook at the bookstore bundled with MyMathLab, or you can purchase MyMathLab that has the e-book by itself. The main consideration is that you have the MyMathLab access; this is a must!

Calculator: A basic scientific calculator can be used during class but NOT during tests.

Course Requirements and Instructional Methods

Homework: There will be **exercises** assigned from every section that we cover to turn in through MyMathLab. There will be 8 homework assignments to be turned in electronically, each worth 25 points.

Tests: There will be two (2) tests during the semester. Tests 1 and 2 will take place at the end of clusters of topics. See the schedule below. **There will be no make-up exams.** If you miss any exam, it will be recorded as a zero, and **the final exam percentage** will be used to replace that score at the end of the semester. If you miss the final, it will be recorded as a zero.

Final Exam: There will be a final exam at the end of the semester, covering a little bit of everything from throughout the course. This test is worth 400 points, or 40% of your overall grade.

Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time **and** two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

Attendance

- A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. - Students are to comply with the following rules of netiquette: (1) identify yourself, (2) include a subject line, (3) avoid sarcasm, (4) respect others' opinions and privacy, (5) acknowledge and return messages promptly, (6) copy with caution, (7) do not spam or junk mail, (8) be concise, (9) use appropriate language, (10) use appropriate emoticons (emotional icons) to help convey meaning, and (11) use appropriate intensifiers to help convey meaning [do not use ALL CAPS or multiple exclamation marks (!!!!)].

Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. If you do not understand how to "cite a source" correctly, you must ask for help.
- Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.

Anyone caught cheating or plagiarizing will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file.
