<u>Course Description</u>: Sight-Singing, dictation and keyboard harmony. Traditional diatonic harmony, four-voice writing and musical analysis.

<u>Prerequisite:</u> Students should have some knowledge of music, such as have participated in band, orchestral or choral programs in K-12 system. Or, is students studied music privately (any instrument), that should suffice. It is also very helpful to take MUS 100 course, Music Foundations before taking this course. However, if one is a quick and ardent learner, even with no prior knowledge, it might be o.k.

<u>Student Learning Outcomes:</u> Upon course completion, the successful student will have acquired new skills, knowledge and or attitudes by being able to 1. Demonstrate knowledge of diatonic triads in major keys (ILO1, ILO2, ILO3, ILO4); 2. Demonstrate knowledge of diatonic triads in minor keys (ILO1, ILO2, ILO3, ILO4); 3. Demonstrate knowledge of seventh chords in major and minor keys (ILO1, ILO2, ILO3, ILO4).

<u>Course Objectives:</u> Upon satisfactory completion of the course, students will be able to: 1. Demonstrate a knowledge of major and minor (natural, harmonic, and melodic) scales through written and analysis. 2. Demonstrate a knowledge of intervals through written harmonization and analysis; 3. Demonstrate a knowledge of triads through written harmonization and analysis; 4. Demonstrate a knowledge of 4-part harmonization using primary chords through written harmonization; 5. Demonstrate knowledge of 4-part harmonization using primary and secondary chords through written harmonization and analysis; and 6. Demonstrate a knowledge of smooth voice leading though written harmonization and analysis.

Textbooks: 1. Tonal Harmony, by Stefan Kostka and Dorothy Payne (any edition)

<u>Class Requirements and Instructional Methods</u>: The student should read the appropriate text for the day's assignment prior to coming to class, be able to discuss and/or ask questions about the day's assignment. Classes will start with an explanation of the text for the current assignment by the instructor, and appropriate examples modeled. This will be followed by "self-tests" in which the student answers the questions in the textbook (also done at home before the next class). The next class will begin with discussions of the "self-tests" and after queries are answered, the assignment of the next section will be given. Thus, students are expected to work diligently on their own, as well as supervised. Make up exams will only be given for

documented extenuating circumstances. Furthermore, make-up exams must be taken no later than 1 week after the original test date. No exceptions!

<u>Class Attendance</u>: A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class, will be dropped by the instructor as of the first official meeting of the class. Anticipated Class Schedule/Calendar, Highly Subject to be Changed depending on Class Progress

Weeks 1 – 4: Chapter 1: Elements of Pitch, the octave registers, notation, major scales, key signatures, minor scales, scale degrees, intervals; perfect major, augmented, minor, and diminished intervals; inversion of intervals.

Weeks 5 – 9: Chapters 2 & 3: Rhythm, durational symbols, beat and tempo, meter, division of the beat, simple and compound time signatures, triads and seventh chords, inversions of chords, figured bass, chord recognition in varied textures.

Weeks 10 - 13: Chapters 4 & 5: Diatonic chords in major and minor keys, seventh chords in major and minor keys, principles of voice leading, the melodic line, notating chords, voicing triads, parallel motion.

Weeks 13 – 16: Chapter 6: Root position part writing; transposing instruments; Review and Final Exam.
