Course Description

A continuation of private lessons in a chosen performance medium at 3rd semester college level. One section meeting per week on campus, in addition to private instruction. As required conditions, the student must: 1. Secure a teacher approved by the College by the 2nd week of classes. 2. Take 13 thirty-minute lessons per semester. 3. Meet on campus for performances as scheduled; and keep accurate records of lesson attendance, ensemble rehearsals, and personal/individual practice logs. (CSU, UC) 4. Present Applied Solo Repertoire in 2 Applied Music Students Concerts; and also participate in 1 Small Ensemble Concert - 1st Solo Concert during 2nd month of classes (October 3rd, 2018), 2nd Solo Concert during the 3rd month of Classes (November 7th, 2018); Small Ensembles Concert the week before Juries (November 28th, 2018). Small Ensembles Rehearsals will be on Thursdays during designated class meeting time (2:40pm to 3:45pm).

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

1. Perform 3rd semester college level pieces with correct pitches, rhythms, dynamics, and articulations. (ILO1, ILO2, ILO3, ILO4)

Upon satisfactory completion of the course, students will be able to:

- 1. Demonstrate the ability to perform two 3rd semester college level pieces with correct pitches.
- 2. Show the ability to perform two 3rd semester college level pieces with correct rhythms.
- 3. Demonstrate the ability to perform two 3rd semester college level pieces with correct dynamics.
- 4. Confirm the ability to perform two college 3rd semester level pieces with correct articulations.
- 5. Demonstrate the ability to play twelve major scales up and down in two octaves.
- 6. Present studied Applied Music Repertoire in 3 Concerts As Defined ABOVE
- 7. All Students will be required to sight-read appropriate level repertoire on Juried Exams

Course Requirements and Instructional Methods

Upon satisfactory completion of the course, students will be able to:

1. Establish and refine technical skills requisite for selected performance literature appropriate for low

division study.

- 2. Perform selected literature with accurate intonation, correct rhythm and dynamics, appropriate style and phrasing, and acceptable tone quality.
- Self-diagnose technical problems in performance and consult with the private instructor on same.
 Prepare and perform before a jury of full-time music faculty and the private instructor Representative literature and technical studies prepared during the semester. The final semester of study, the jury is replaced by the presentation of public recital featuring representative works of various contrasting style which shall also be judged by the faculty jury.

Two (2) hours of independent work done out of class per each hour of lecture or class work, or 3 hours lab practicum, or the equivalent per unit is expected.

Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

Course Grading Based on Course Objectives

The student will prepare and perform before a jury of full-time music faculty and the private instructor representative literature and technical studies prepared during the semester.

Judges will grade the performance based on the 11 aspects of music performance. Also, the 3 Semester Concert performances (2 Solo Performances and 1 Small Ensemble Performance), will be graded. **GRADING CRITERIA:-**

Attendance

A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. Should
