Course Description

A first course in linear algebra intended for students majoring in mathematics, the physical sciences, engineering or business. This course develops the techniques and theory needed to solve and classify systems of linear equations. Solution techniques include row operations, Gaussian elimination, and matrix algebra. Investigates the properties of vectors in two and three dimensions, leading to the notion of an abstract vector space. Vector space and matrix theory are presented including topics such as inner products, norms, orthogonality, eigenvalues, eigenspaces, and linear transformations. Selected applications of linear algebra are included. (CSU, UC)

Course Prerequisite(s) and/or Corequisite(s)

Prerequisite: MATH 194 with C or better

Student Learning Outcomes

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

1. Perform matrix operations, and compute determinants, eigenvalues,/vectors, and inverses. (ILO2)
2. Understand and apply the relationship between linear transformations, matrices and systems of equations. (ILO2)
3. Analyze, synthesize, and evaluate theorems in Linear Algebra. (ILO2)

Course Objectives

Upon satisfactory completion of the course, students will be able to:

1. Find solutions of systems of equations using various methods appropriate to lower division linear algebra.
2. Use bases and orthonormal bases to solve problems in linear algebra.
3. Find the dimension of spaces such as those associated with matrices and linear transformations.
4. Find eigenvalues and eigenvectors and use them in applications.
5. Prove basic results in linear algebra using appropriate proof-writing techniques such as linear independence of vectors; properties of subspaces; linearity, injectivity and surjectivity of functions; and properties of eigenvectors and eigenvalues.

Course Requirements and Instructional Methods

Material needed: paper, pen, pencil, highlighter, calculator

Course setting: This course is designed to have you learn facts while gaining an appreciation of the power of Mathematics and getting ready for your future courses in this field. My responsibility is to do my best to be an effective guide, while you are responsible to make a commitment to learning and keeping up with the daily work. Remember mathematics is learned through active participation.

On daily basis you need to:

- Use provided lectures and book materials to study the day's topics and take notes as needed.
- Work on the assignments.
- Know and attain the pre-requisite topics learned in previous courses.

Class Rules:

2. **No** make-up test will be given
3. Bring your binder, pen, pencil, and highlighter to the class every day.
4. It is the student's responsibility to drop or officially withdraw from the class.

Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. For this class that means approximately 6 hours of studying, working on assignments and reviewing for the tests outside the class time per week.

Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.
