### Course Description

This course is an introduction to the theory of discrete mathematics and introduces elementary concepts in logic, set theory, graph theory, number theory and combinatorics. This forms a basis for upper division courses in mathematics and computer science, and is intended for the transfer student planning to major in these disciplines. The topics covered in this course include methods of proof, sets and relations, functions, number theory, induction, recursion, counting principles and probability trees, permutations, combinations, introduction to computer programming, and graph theory. (CSU, UC)

### Course Prerequisite(s) and/or Corequisite(s)

**Prerequisite:** MATH 192 with C or better

### Student Learning Outcomes

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

1. Use a truth table to test the validity of an argument. (ILO1, ILO2, ILO4)
2. Construct proofs of mathematical statements using standard techniques, including induction. (ILO1, ILO2, ILO4)
3. Apply graph theory to real world situations. (ILO1, ILO2, ILO4)

## Course Objectives

Upon satisfactory completion of the course, students will be able to:

1. Write proofs using symbolic logic and Boolean Algebra.
2. Use recursion to analyze algorithms and programs.
3. Use sets to solve problems in combinatorics and probability theory.
4. Apply matrices to analyze graphs and trees.
5. Use finite state machines to model computer operations.

## Course Requirements and Instructional Methods

**Material needed:**, paper, pen, pencil, highlighter, calculator

**Course setting:** This course is designed to have you learn facts while gaining an appreciation of the power of Mathematics and getting ready for your future courses in this field. My responsibility is to do my best to be an effective guide, while you are responsible to make a commitment to learning and keeping up with the daily work. Remember mathematics is learned through active participation.

**On daily basis you need to:**

- Use provided lectures and book materials to study the day's topics and take notes as needed.
- Work on the assignments.
- Know and attain the pre-requisite topics learned in previous courses.

**Class Rules:**

2. **No** make-up test will be given
3. Bring your binder, pen, pencil, and highlighter to the class every day.
4. It is the student's responsibility to drop or officially withdraw from the class.

**Out of Class Assignments:** The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. **For this class that means approximately 6 hours of studying, working on assignments and reviewing for the tests outside the class time per week.**

## Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.
