# **Basic Course Information**

#### **Course Description**

This course is designed to assist students in the development of critical thinking and decision-making skills in the small group communication context. An emphasis is placed on the basic elements of critical thinking, such as evidence, reasoning, and language. In addition to examining these basic elements, students will become familiar with leadership strategies, discussion techniques and conflict management skills used in groups. (Formerly SPCH 130) (CSU, UC)

### Student Learning Outcomes

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

- 1. Conduct a meeting using the principles of Parliamentary Procedure. ILO1, ILO2, ILO3, ILO4, ILO5
- 2. Find a problem and work as a group to find a solution to that problem. ILO1, ILO2, ILO3, ILO4, IOL5
- 3. Identify the negative behaviors in poorly-functioning groups. ILO1, ILO2, ILO3, ILO4, ILO5

#### **Course Objectives**

Upon satisfactory completion of the course, students will be able to:

- 1. Exhibit effective problem-solving communication skills.
- 2. Demonstrate successful conflict-management strategies.
- 3. Demonstrate the ability to discover, critically evaluate, and engage in sound reasoning to reach a wellrounded decision.
- 4. Identify communication skills that contribute to effective leadership.
- 5. Organize presentations effectively.
- 6. Demonstrate ability to effectively prepare for and deliver presentations within small group settings.
- 7. Explain the psychological, social, and cultural basis and significance of oral communication as it occurs in dyads, small and large groups, and public settings.
- 8. Demonstrate effective listening skills in various settings.
- 9. Adapt communication strategies to fit the audience and situation.
- 10. Present their views with persuasive force.

# Course Requirements and Instructional Methods

- In Class Activities: In-Class Activities: These activities are done in class and help teach the basics of group communication skills. These activities CANNOT be made up.
- Group observation report (Individual assignment): Attend a meeting of a local small group such as a nonprofit, the Academic Senate, an on-campus committee, a church leadership team meeting, etc. Take notes at the meeting. A write up is due in class on 10/1/19. Specific assignment parameters will be given in class.
- Group Comm Analysis Paper (Individual assignment): Using a communication theory about group communication, analyze the public meeting attended for the group communication observation. Specific assignment parameters will be given in class.
- Exams (2): Exams: The exams are broken into two parts. The first exam covers the first six chapters of the OER textbook and lectures. The second exam covers the last six chapters of the OER textbook and lectures occurring after the first exam. The exams will be a mix of fill-in-the-blank, short answer, and essay questions. Again, the exams cover the required readings and in-class lectures. Group exams are a possibility.
- Small Group Service Project: Working in a group of 4-5 of your peers, you all will design and complete a group service project. Groups and topics will be selected in the first two weeks of class.
  Working in groups, you will design and complete a service project that will help with a local need. The project topic must be approved by Sabrina. Your group will then do a group presentation on the last day on class revealing the results of your efforts to your peers.
  Specific assignment parameters will be given in class.
- Personal Journal/Reflection: A 3-4 page personal reflection on your own involvement in the Group Service Project (GSP). The paper should be well-written and should reveal insight into how you function in the group setting, what are your strengths and weaknesses, and what can you do going forward to increase the success of your group? Specific assignment parameters will be given in class.

"Assignments: It is your responsibility to complete all assignments in a timely matter and submit them via the appropriate channels (in person or electronically, depending on the assignment). In general, NO late work will be accepted, even with documentation. All assignments need to be typed, unless otherwise specified," SW. Out of Class Assignments: The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement. \*Assignments and class schedule are subject to change. Said changes are likely only announced during class time. Students are responsible for changes, regardless of class attendance.

Attendance

- "A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. Should readmission be desired, the student's status will be the same as that of any other student who desires to add a class. It is the student's responsibility to drop or officially withdraw from the class. See General Catalog for details.
- Regular attendance in all classes is expected of all students. A student whose continuous, unexcused absences exceed the number of hours the class is scheduled to meet per week may be dropped.
