*Class Requirements and Instructional Methods:* The student should read the appropriate text for the day's assignment prior to coming to class, be able to discuss and/or ask questions about the day's assignment. This will be followed by "self-tests" in which the student answers the questions in the textbook (also done at home before the next class). The next class will begin with discussions of the "self-tests" and after queries are answered, the assignment of the next section will be given. Thus, students are expected to work diligently on their own, as well as supervised. Classwork and Self-Tests will be GRADED. Please do them. Make up exams will only be given for documented extenuating circumstances. Furthermore, make-up exams must be taken no later than 1 week after the original test date. No exceptions!

**Out of Class Assignments:** The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester.
