#### **Course Description**

This course is designed to facilitate the learning of third (3rd) semester nursing knowledge, skills and concepts through individualized, computer enhanced and nursing tutor medicated instruction (nontransferable, nondegree applicable).

# Course Prerequisite(s) and/or Corequisite(s)

Student must be enrolled in third (3rd) semester of the nursing program (N107, N109, VN110, VN112, VN114, VN 116).

Upon course completion, the successful student will have acquired new skills, knowledge and/or attitudes as demonstrated by being able:

- Demonstrate new learning or study techniques and appropriate application to third (3rd) semester nursing degree courses (ILO2, ILO3)
- Demonstrate knowledge, skills and attitudes about patient safety and their role in preventing medical errors specific to third (3rd) semester nursing degree courses (ILO4).

Upon satisfactory completion of the course, students will be able to:

• Review clinical skills and procedures specific to third (3rd) semester level nursing content

- Demonstrate minimum competency with assigned clinical skills specific to third (3rd) semester level nursing content
- Discuss methods to improve study habits, test-taking and time management skills specific to third (3rd) semester level nursing content
- Review drug calculation, including IV administration and calculation specific to third (3rd) semester nursing content
- Develop nursing care plans and concept maps specific to third (3rd) semester level nursing content
- Demonstrate competency with computer assisted instruction specific to third (3rd) semester level nursing content
- Complete level specific on-line assessment exams specific to third (3rd) semester level nursing content
- Complete course specific remediation contracts specific to third (3rd) semester level nursing content

### **Course Grading Based on Course Objectives**

Grading criteria is pass/no pass. Upon completing at least 54 hours of individual study in the nursing learning center and attending weekly scheduled tutoring sessions, the student will receive a credit (pass) grade for this class. #### Attendance

• A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. Should readmission be desired, the student's status will be the same as that of any other student who desires to add a class. It is the student's responsibility to drop or officially withdraw from the class. See General Catalog for details.

- Regular attendance in all classes is expected of all students. A student whose continuous, unexcused absences exceed the number of hours the class is scheduled to meet per week may be dropped. For online courses, students who fail to complete required activities for two consecutive weeks may be considered to have excessive absences and may be dropped.
- Absences attributed to the representation of the college at officially approved events (conferences, contests, and field trips) will be counted as 'excused' absences.

#### **Classroom Etiquette**

- Electronic Devices: Cell phones and electronic devices must be turned off and put away during class, unless otherwise directed by the instructor.
- Food and Drink are prohibited in all classrooms. Water bottles with lids/caps are the only exception. Additional restrictions will apply in labs. Please comply as directed by the instructor.

# **Online Netiquette**

- What is netiquette? Netiquette is internet manners, online etiquette, and digital etiquette all rolled into one word. Basically, netiquette is a set of rules for behaving properly online.
- Students are to comply with the following rules of netiquette: (1) identify yourself, (2) include a subject line, (3) avoid sarcasm, (4) respect others' opinions and privacy, (5) acknowledge and return messages promptly, (6) copy with caution, (7) do not spam or junk mail, (8) be concise, (9) use appropriate language, (10) use appropriate emoticons (emotional icons) to help convey meaning, and (11) use appropriate intensifiers to help convey meaning [do not use ALL CAPS or multiple exclamation marks (!!!!)].

### **Academic Honesty**

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. If you do not understand how to "cite a source" correctly, you must ask for help.
- Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.

Anyone caught cheating or plagiarizing will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file. Repeated acts of cheating may result in an F in the course and/or disciplinary action. Please refer to the General Catalog for more information on academic dishonesty or other misconduct. Acts of cheating include, but are not limited to, the following: (a) plagiarism; (b) copying or attempting to copy from others during an examination or on an assignment; (c) communicating test information with another person during an examination; (d) allowing others to do an assignment or portion of an assignment; (e) using a commercial term paper service.
