### Course Description

A second course in differential and integral calculus of a single variable: integration; techniques of integration; infinite sequences and series; polar and parametric equations; applications of integration. Primarily for Science, Technology, Engineering & Math Majors.

MATH 192 with a minimum grade of C or appropriate placement as defined by AB705

### Student Learning Outcomes

Demonstrate problem solving strategies by identifying an appropriate method to solve a given problem, correctly set up the problem, perform the appropriate analysis and computation, and share their interpretation of the conclusion or the outcome, using correct grammar or in an oral presentation. This outcome will be assessed through selected exercises on exams throughout the semester. (ILO1, ILO2)

### Course Objectives

Upon satisfactory completion of the course, students will be able to:

1. Evaluate definite and indefinite integrals using a variety of integration formulas and techniques
2. Apply integration to areas and volumes, and other applications such as work or length of a curve
3. Evaluate improper integrals

4. Apply convergence tests to sequences and series
5. Represent functions as power series
6. Graph, differentiate and integrate functions in polar and parametric form

8. Reading the sections of the textbook corresponding to the assigned homework exercises is considered part of the homework assignment. You are responsible for material in the assigned reading whether or not it is discussed in the lecture.

### Attendance

## Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. - Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.
