### Course Description

This course seeks to enable you to identify the historical sources of United States criminal laws; demonstrate knowledge of the United States Constitution and other key documents of the criminal justice system; analyze and explain criminal appellate cases; compare and contrast the classifications of criminal laws. Crimes against persons, property, and government will also be discussed. As the college catalogue suggests, a good command of English is important to success in this course because we will have to master the legal terminology which defines the legal system. Your success will be determined by testing and by an case study assignment as discussed below.

You are required to submit a four page (minimum/maximum) typewritten report including a cover page and a bibliography (1 cover page + 2 typed complete content pages + 1 bibliography page). A minimum of three sources must be listed on your bibliography page and information taken from those sources cited throughout your report. Wikipedia sources are not acceptable. Term papers are due the final week of class.

**Out of Class Assignments:** The Department of Education policy states that one (1) credit hour is the amount of student work that reasonably approximates not less than one hour of class time and two (2) hours of out-of-class time per week over the span of a semester. WASC has adopted a similar requirement.

## Attendance

- Students are to comply with the following rules of netiquette: (1) identify yourself, (2) include a subject line, (3) avoid sarcasm, (4) respect others' opinions and privacy, (5) acknowledge and return messages promptly, (6) copy with caution, (7) do not spam or junk mail, (8) be concise, (9) use appropriate language, (10) use appropriate emoticons (emotional icons) to help convey meaning, and (11) use appropriate intensifiers to help convey meaning [do not use ALL CAPS or multiple exclamation marks (!!!!)].

## Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. If you do not understand how to "cite a source" correctly, you must ask for help.
- Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.

Anyone caught cheating or plagiarizing will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file.
