## **Course Description**

An introduction to debate, with emphasis on the creation and refutation of arguments concerning current social, political, and legal issues

Upon completion of this course, the student will be able to:

- 2) Write and submit five properly-worded debate propositions (ILO1, ILO2, ILO3, ILO4, ILO5)
- 3) Use logos to support their arguments during the debate process. (ILO1, ILO2, ILO3, ILO4, ILO5)

## **Course Objectives**

- 1) The student will be able to create, critique, and refutearguments.
- 2) The student will be able to identify fallacious argumentation.
- The student will be familiar with the most commonly debated topics (i.e., gun control, capital punishment, legalization of prostitution, animal rights, euthanasia, etc.) and the arguments that are typically made in these debates.
- 4) The student will participate in formal classroom debates.
- 5) The student will understand the responsibilities of the proposition vs. opposition as well as the role of each speaker on each team.

Talking: Students are expected to refrain from talking privately to other students during lectures, group discussions and debates.

Disruptive Students: Students who disrupt or interfere with a class may be sent out of the room and told to meet with the Campus Disciplinary Officer before returning to continue with coursework. ### **Academic Honesty**

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property. There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. If you do not understand how to "cite a source" correctly, you must ask for help.
- Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.

Anyone caught cheating or plagiarizing will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file. Repeated acts of cheating may result in an F in the course and/or disciplinary action. Please refer to the General Catalog for more information on academic dishonesty or other misconduct.
