Course Description

This course is an introduction to assessment and treatment approaches to Alcoholism and Drug Abuse. Alcoholism will be studied in its social and clinical context. Attention will be given to the basic theoretical approaches to the disease. This course will examine the various components of intervention, treatment, recovery, referrals and resources. (CSU)

8. Demonstrate understanding of screening and assessment the alcoholic/addict.
9. Demonstrate treatment planning.
10. Demonstrate Counseling skills for individuals, group and family.

You do not have to write what you think I would agree with, you just need to justify your ideas and statements with explanations.

Tests: There will be a total of four (4) tests given throughout the semester. All tests will be multiple choices and/or true/false. All tests are worth 100 points.
