COURSE/CATALOG DESCRIPTION

Designed for older students who have an interest in learning to sing and who enjoy music. Breath control, tone placement, articulation and enunciation. Rehearsal, performance and study of choral literature. Introduction to music theory as a means of learning to read music rather than learning by rote. The course intends to assist older adults in identifying and examining personal interest and aptitudes in music to enhance mental acuity and creativity, as well as appreciation of the arts.

Students will attend scheduled musical performances and give of their best. Students will be orderly and disciplined during choir classes and performances, and endeavor to maintain proper decorum. Talking should be minimized or non-existent during rehearsals and performances. Students will be great team-members of the choral ensemble. Students will gain confidence in themselves as blossoming musical artistes. Please note that this is a Choral Performance Class, hence participation in Concerts is important and mandatory. Concert/Performance Schedule thus Far (subject to change):- Performances are Friday March 6 th , 2020 at 5:30pm (I.V. Fair); Thursday April 9 th , 2020 at 1:15pm (IVC Cafeteria); Thursday June 4 th , 2020 at 1:15pm (IVC Cafeteria); Saturday June 6 th , 2020 at 4:00pm (Community Venue in El Centro, CA); Saturday June 13 th , 2020 at 9:00am and 2:00pm (IVC Commencement Ceremonies, IVC GYM).
