Course Description

This course is designed to help students with a disability, or multiple disabilities, to understand their computer usage capabilities and to determine, through an instructor's evaluation, the appropriate assistive computer technologies needed to enhance their learning and productivity. (Nontransferable, AA/AS degree only)

Course Prerequisite(s) and/or Corequisite(s)

A student must be eligible for services and instruction from the Disabled Student Programs and Services, through appropriate verification of a primary disability by certificated personnel, and be able to benefit from the programs and services offered by the High Tech Center.

Student Learning Outcomes

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

- Demonstrate a clear understanding of their computer access capabilities and the assistive computer technologies that meet their needs (ILO1, ILO4).

Course Objectives

Upon satisfactory completion of the course, students will be able to:

1. Demonstrate keyboard access capabilities.
2. Learn to perform basic computer operations to enter, exit, locate and save information.
3. Identify the access devices and appropriate software that meet their needs.
