Course Description

Topics include right angle trigonometry and applications, unit circle trigonometry, graphs of trigonometric functions, inverse trigonometric functions, trigonometric identities, solving triangles by using the Laws of Sines and Cosines, and polar coordinates.

Course Prerequisite(s) and/or Corequisite(s)

Math 091 with a grade of “C” or better, or appropriate placement.

Student Learning Outcomes

Upon successful completion of this course, a student will: 1. Verify trigonometric identities (ILO2) 2. Solve a triangle, given two sides and the angle in between. (ILO2) 3. Show understanding in solving trigonometric equations (ILO2)

Course Objectives

1. Define the six trigonometric functions using right triangle and unit circle definitions.
2. Express angles in degrees and radians.
3. Graph trigonometric functions, including those involving vertical and horizontal translations.
4. Solve triangles using the Law of Sines and Law of Cosines, including ambiguous cases.
5. Verify trigonometric identities, including sum and difference formulas, half-angle and power-reducing formulas.
6. Define and graph inverse trigonometric functions.
7. Solve trigonometric equations.
8. Graph polar coordinates and equations.
9. Solve application problems.

Course Requirements and Instructional Methods

Homework

Homework will be assigned at each class meeting. They should be on stapled arranged in the correct order. Please write your name and section number on the top right corner. Late homework will NOT be accepted. No make-up homework. At the end of the semester one lowest homework score will be dropped. It is your responsibility to check the homework assignment even if you are absent. The first 10 minutes of class will be devoted to answering your questions.

Quiz/Pop-quiz/Group Work

Tests

There will be four tests. No make-up tests will be given. The lowest score of the chapter tests will be dropped. If a test is missed, it will be the test score that is dropped. The purpose of these tests is to check your understanding of the concepts covered in the course. Most of the questions on these tests will require showing a significant amount of work. A correct answer with insufficient work will receive partial credit or no credit.

Final Exam

At the end of the semester, a COMPREHENSIVE/CUMULATIVE Final Exam will be given. If you miss the final, it will be recorded as a zero.

Attendance

(11) use appropriate intensifiers to help convey meaning [do not use ALL CAPS or multiple exclamation marks (!!!)].

Academic Honesty

Academic honesty in the advancement of knowledge requires that all students and instructors respect the integrity of one another's work and recognize the important of acknowledging and safeguarding intellectual property.

There are many different forms of academic dishonesty. The following kinds of honesty violations and their definitions are not meant to be exhaustive. Rather, they are intended to serve as examples of unacceptable academic conduct.

- Plagiarism is taking and presenting as one's own the writings or ideas of others, without citing the source. You should understand the concept of plagiarism and keep it in mind when taking exams and preparing written materials. - Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.
