- If student is a 'NO SHOW' for any exam/final exam will receive an 'F' on exam including the unit or units. Student will not be able to participate in clinical rotation.

#### NOTE:

If the student withdraws from the course the student must withdraw online by December 1, 2022.

After this date the student will receive a letter grade of an 'F' at the end of the course.

## Attendance

- A student who fails to attend the first meeting of a class or does not complete the first mandatory activity of an online class will be dropped by the instructor as of the first official meeting of that class. Should readmission be desired, the student's status will be the same as that of any other student who desires to add a class.
