This course is designed to give water plant operators a comprehensive understanding of freshwater treatment plant safety, iron and manganese control, fluoridation, softening, demineralization, handling, disposal of process wastes, instrumentation, maintenance, groundwater plant operations, advanced math, rules and regulations, laboratory procedures, and supervisory practices. # **Course Requirements and Instructional Methods**

This is a Face-to-Face college format class; the student is required to physically attend class on college as scheduled it. Specific instructions and assignments will be available only through Zoom and Canvas.

#### **Course Policies**
