- 8. Explain the preservation and custody of physical and scientific evidence.

You must make a 5 minute oral presentation on a criminal justice topic of your choosing. You may use powerpoint or any other visual aid if you so desire. You must speak in a loud, clear voice and make eye contact with the class. *No videos allowed*.

Attendance
