#### **Course Description**

This course will cover the functions and responsibilities of caregiving for older adults in both formal and informal settings. Students will explore the physical as well as social and emotional needs of those receiving care. Topics include elder abuse, family caregiving, end of life care, death, dying and grief, older adult care issues and risk reduction and home safety. (Nontransferable, AA/AS degree only)

# **Student Learning Outcomes**

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

- 1. Identify areas of safety concern in an elderly client's home
- 2. Verbalize procedure for reporting elder neglect and abuse
- 3. Identify resources to assist client and family with dying, death and grief

#### **Course Objectives**

Upon satisfactory completion of the course, students will be able to:

- 1. Apply knowledge of nutrition and hydration as well as established evidence-based practice to the care of older adult patients with common nutritional health alterations.
- 2. Identify the main diseases and the principles behind the different care therapies associated with each one.
- 3. Adhere to ethical, legal and professional standards while maintaining accountability and responsibility for the care of an older adult.



- 4. Describe the impact of aging on safety for older adults, the problems of falls and interventions to prevent and reduce risks to safety.
- 5. Identify health and safety education needs focusing on maintaining optimum level of quality of life of older adults and their families.
- 6. Demonstrate decision-making when identifying and reporting health deviations and treatment- related responses of older adults.
- 7. Describe the impact of age-related changes that address the safety concerns of older adults such as protection from fire, prevention of falls, and medical concerns such as medication management and care provider issues.

# **Course Requirements and Instructional Methods**

# **Class Activity**

Team presentations on assigned topics.

Oral and Written Assignments

Participate in class discussions on a range of topics related to elder abuse, safety concerns and end of life care.

#### Quizzes

There will be quizzes at the beginning of class to review material from previous classes.

Lecture

Out-of-class assignments

Students will participate in discussion boards. Students will watch assigned videos and respond to discussion questions. Students will complete a home self-evaluation using the checklist from the National Institute on Aging "Home Safety."



### **Course Grading Based on Course Objectives**

#### Attendance:

- Regular attendance in all classes is expected of all students.
- This course consists of a total of 32.5 hours.
- Students taking the course for credit (certificate option) need to be in class for 27.5 hours or more (85%) in order to pass the class. This means you may only be absent for 2 classes.
- Students taking the course for the Pass/No Pass option must be in class 23 hours or more (70%) in order to pass the class. This means you may only be absent for 4 classes.

#### **Classroom etiquette:**
