Course Description

Designed to satisfy the Regular Basic Course Modular Format Level II training standards as set forth by the Commission on Peace Officer Standards and Training (P.O.S.T.). Includes policing in the community, property crimes, crimes against persons, death investigations, general criminal statutes, laws of arrest, search and seizure, presentation of evidence, investigative report writing, use of force de-escalation, patrol techniques, vehicle pullovers, crimes in progress, crime scene, evidence, forensics, arrest and control, firearms training, chemical agents, crimes against the justice system, cultural diversity, and use and care of firearms. Supply fee may be charged. Designed to prepare students to be hired by a law enforcement agency as a Reserve Officer Level II. (Formerly AJ 142) (CSU)

Course Prerequisite(s) and/or Corequisite(s)

Regular Basic Course Level III POST 160 (Formerly AJ 162). Successful completers that have been appointed by a law enforcement agency may perform specified limited support duties, and other duties that are not likely to result in physical arrests, while supervised in the accessible vicinity by a Level I reserve officer or a full-time regular officer. Additionally, Level III reserve officers may transport prisoners without immediate supervision. See specified requirements in Penal Code sections 830.6(a) (1) and 832.6(a) (2). The student who would like to enroll into POST 162 must meet ALL eligibility requirements listed below.



- Successfully complete POST 160 (Formerly AJ 160) Regular Basic Course Level III (within the last 3 years). Training must be current in conformance with the requirements of Regulation 1080 Passage of the POSTconstructed Comprehensive Module III End-of-Course Proficiency Test within the preceding 12 months Individuals who have completed previous versions of the Level III and/or Level II Modules may enter the current Modules II and or I, as applicable.
- 2. Complete and submit an application with all requested information attached 2 weeks prior to the start of the semester.
- 3. Department of Justice (DOJ) Clearance Letter. DOJ clearance must be completed prior to the start of the course. a. Students, who do not pass the DOJ clearance process, will not be admitted to the course.
 - b. A Department of Justice (DOJ) clearance letter is good for 90 days.
 - c. If the 90 days expires prior to the start of class, the student must obtain a new clearance letter.
 - d. Students who change from one POST 160 class to another in the same semester, same school, and within 90 days, do not need a new clearance letter.
 - e. For further information contact the Administrative Justice/POST Department Office
 - f. Valid California driver's license and evidence of current insurance coverage.
- 4. Ability to successfully participate in physical requirements of course.
- 5. U.S. citizen or have filed for U.S. citizenship.
- 6. Must have a valid social security number prior to admission
- 7. Proof of high school graduation or GED
- 8. Be at least 18 years of age at the time of admission

Student Learning Outcomes

Upon course completion, the successful student will have acquired new skills, knowledge, and or attitudes as demonstrated by being able to:

- 1. Demonstrate approved defense and control techniques as established by P.O.S.T.
- 2. Demonstrate proficiency with departmental approved firearm, including nomenclature, range safety, loading, unloading, aiming, accuracy, and trigger manipulation.
- 3. Pass the written portion on the P.O.S.T. End of Course Examination.

Course Objectives

Upon satisfactory completion of the course, students will be able to:

- 1. Become familiar with crime against persons, property crimes, crimes against children, sex crimes, weapons violations, general crime statues, and crimes against the justice system. The student will satisfactorily demonstrate knowledge in the areas of laws of arrest and search & seizure.
- 2. Satisfactorily demonstrate knowledge, awareness and application in the concepts and practice of use of force, arrest and control, baton, firearms, and chemical agents.
- 3. Demonstrate effective written and oral communication skills through satisfactory investigative report writing.
- 4. Demonstrate appropriate knowledge, awareness, and sensitivity in the areas of cultural diversity, discrimination, and person with disabilities.
- 5. Practice physical fitness and demonstrate an understanding of the wellness requirements inherent in the profession.



- 6. Satisfactorily demonstrate knowledge of patrol techniques which will include but are not limited to vehicle pullovers, crimes in progress, preliminary investigations, and hazardous materials awareness.
- 7. Practice communication skills and demonstrate an awareness and knowledge in crisis intervention, victimology, and police community relations.
- 8. Demonstrate the correct method for the preservation and presentation of evidence.
- 9. Demonstrate knowledge in the core principles of policing in the community and appropriate law enforcement officer responses to critical incidents and crimes in progress.
- 10. Satisfactorily pass the P.O.S.T. constructed comprehensive tests.

Failure of any P.O.S.T. Written and/or Practical Exam will generate a Remediation Exam**

Failure of the Remediation Exam will cause an immediate failure and removal from the course**

- P.O.S.T. Arrest & Control Practical Exam = PASS/FAIL
- P.O.S.T. Chemical Agent Practical Exam = PASS/FAIL
- P.O.S.T. Firearms Marksmanship and Safety Exam = PASS/FAIL
- P.O.S.T. End of Course Exam = Final calculated grade determined by POST will factor in final class grade.

**PLEASE NOTE: POST training and testing mandates require a passing score, determined by the POST computerized program, for each examination conducted in the Module 2 presentation/class. Exams will be given following all required training or remediation training for retesting purposes. If you are late to class, you will not be given extra time to take an exam. You must communicate to your instructor any problems that you are having with the course.



Course Policies

- P.O.S.T. classes supersede standard attendance rules of IVC.
- P.O.S.T. restricts absences for any reason to less than 5% of the total course, no exceptions.
- If you miss more than 5% of the course, you will be dropped.
- If you miss any mandatory or State Legislative portions of the course, you will be dropped.

- Cheating is defined as fraud, deceit, or dishonesty in an academic assignment, or using or attempting to use materials, or assisting others in using materials that are prohibited or inappropriate in the context of the academic assignment in question.

Anyone caught cheating or plagiarizing will receive a zero (0) on the exam or assignment, and the instructor may report the incident to the Campus Disciplinary Officer, who may place related documentation in a file. Repeated acts of cheating may result in an F in the course and/or disciplinary action. Please refer to the General Catalog for more information on academic dishonesty or other misconduct. Acts of cheating include, but are not limited to, the following: (a) plagiarism; (b) copying or attempting to copy from others during an examination or on an assignment; (c) communicating test information with another person during an



examination; (d) allowing others to do an assignment or portion of an assignment; (e) using a commercial term paper service.

P.O.S.T. exams are also covered under the California Code of Regulations and an act of cheating may be punishable by a \$5,000 fine for each act and immediate disciplinary action.
